**Purpose:** 

The Disclosure and Barring Service (DBS) provides criminal records checking and barring functions to help employers make safe recruitment decisions.



**History/Relevant Reports** 

- Formally Criminal Records Bureau (CRB)
- > Bichard Inquiry Recommendation 2004
- Safeguarding Vulnerable Groups Act 2006 introduction of vetting and barring scheme
- DBS Established under the Protection of Freedoms Act 2012 (from 1st Dec 2012). Formerly Criminal Records Bureau (CRB) and Independent Safeguarding Authority ISA) into a new nondepartmental public body that could administer a proportionate central vetting service

Exempt under the Rehabilitation of Offenders Act 1974

What is an "exempted" question?

For DBS purposes – "if a position involves working with children and/or vulnerable adults, the employer has the right to ask an individual to reveal their full details of both spent and unspent convictions due to the nature of work they will undertaking"



Roles that are regulated activities

- > Teachers
- Childcare workers
- > Nurses and General Practitioners (GPs)
- > All staff in schools
- Care workers
- Some charity Trustees
- > Sporting coaches
- Sunday school teachers
- > Prison Officers
- Law enforcement Officers



**DBS Checking Process** 

- Stage 1 Application
- Stage 2 Police National Database (PNC)
- Stage 3 Children and Adults Barred lists
- > Stage 4 Records held by law enforcement checked
- Stage 5 DBS certificate issued



- **Types of Checks**
- Standard £26
- Enhanced DBS check plus Barred Lists £44
- > Volunteers Free (UK)
- Transgender Process confidential checking system for transgender applicants (0151 676 1452)



# Freedom Of Information (FOI) reference: 1101 / Issued: 9/12/13

As at 31 October 2013:

- 45,970 individuals included in the Adults' Barred List, of whom 38,552 (84%) are male and 7,418 (16%) female.
- 50,791 individuals included in the Children's Barred List of whom 44,491 (88%) are male and 6,300 (12%) are female.
- There are 43,360 individuals included in both Barred Lists of whom 37,516 (87%) are male and 5,844 (13%) are female.
- The figures below represent those individuals included in one Barred List only, therefore not across both Barred Lists as noted above.
- There are 2,610 individuals included in the Adults' Barred List only, of whom 1,036 (40%) are male and 1,574 (60%) are female.
- There are 7,431 individuals included in the Children's Barred List only, of whom 6,975 (94%) are male and 456 (6%) are female.

# **International Perspective: NCA (CEOP Command)**

### **Benefits of this Approach?**

- Allows for direct consultation with people in country
- Act as a catalyst to form national group, identify local needs
- International benefits domestic case resolution, mutual threats identified and key data shared.
- Underwrites thinking to identify need for capacity building in country, impacts on funding requirement.
- Training develops effective operational partnerships
- Exit Strategy Empowers professionals locally



## **International Perspective: Benefits of this Approach?**

- Improves Intelligence flows reporting of suspicious activity of UK offenders
- Operational support Use of credible local social workers utilising knowledge with the Advisory Panel.
- ICPN Activity no core funding. External funding from government and corporate partners



## **UK Law Enforcement Response ? Creation of the .....**

#### The International Child Protection Certificate (ICPC)





## What is ICPC?

- A certificate obtained by UK Nationals or people who have spent time in the UK.
- List all convictions, cautions, reprimands and final warnings known to UK police
- Cost £60; issued with 10 working days
- Promotion for international schools to adopt as part of their mandatory recruitment procedures





## **ICPC Checks Conducted by ACRO**

- Police National Computer All English and Welsh offences
- Foreign convictions are included where available and checked for accuracy via the UK Central Authority for the Exchange of Criminal Convictions based in ACRO.
- CHS Scottish Database of Criminal Convictions
- Causeway Police Service of Northern Ireland Database of Criminal Convictions
- Redcap Military Police Database of Criminal Convictions
- Police National Database
- Child Exploitation Tracking System (CETS) CEOP Command

## Conclusion

- DBS provides a greater coordination centralised process for stringent Identity verification
- Safeguarding children from sexual exploitation and abuse offenders
- Provides reassurance to organisations that employees are suitable for working with children
- ICPC deterrent for Transnational Child Sex Offenders (TCSOs) who travel overseas to abuse children
- International cooperation among law enforcement, internet industries, NGOs and other charitable organisations
