Follow-up to the conclusions adopted by the conference

Secretariat memorandum

prepared by the Directorate of Environment and Local Authorities

INTRODUCTION

- 1. The 5th Conference of European Ministers responsible for Local Government (actually, the 6th if account is taken of the ad hoc conference held in Lisbon in 1977) took place in Lugano from 5 to 7 October 1982 at the invitation of the Federal Councillor, Mr Pierre Aubert, member of the Swiss Government, Head of the Federal Department for Foreign Affairs.
- 2. Nineteen member states of the Council of Europe were represented (Iceland and Malta having sent apologies), 12 at ministerial level (Minister or Secretary of State) and 7 by senior officials. The latter included two states, the Federal Republic of Germany and Sweden, which had officially announced the participation of their Minister of the Interior. The Ministers concerned were replaced by senior officials following a change of government in the two states on the eve of the conference.

- 3. The Chair was taken by Federal Councillor, Mr Pierre Aubert. In view of the fact that he had to be absent at the end of the third session and during the fourth session because of government business, he was replaced by Mr Marino Corder, Under-Secretary of State at the Italian Ministry of the Interior, who had been elected Vice-Chairman as representative of the host country to the next conference, the 6th, to be held in Rome in 1984.
- 4. In pursuance of Resolution (71) 44 on Conferences of Specialised Ministers, the Secretary General provided secretarial services for the conference whose preparation had been assigned, by decision of the Ministers' Deputies at their 325th meeting, to the Steering Committee for Regional and Municipal Matters (CDRM).
- 5. This memorandum, submitted to the Committee of Ministers in pursuance of item 8 of Resolution (71) 44 sets out briefly the conference's aims and conclusions, which are contained in Appendix IV to this document and formulates suggestions about further action which might be taken by the Committee of Ministers.

6. AIMS AND CONCLUSIONS OF THE CONFERENCE

The conference had two themes:

- I. Local autonomy: legislation, practice, prospects
- II. The state of transfrontier co-operation between territorial communities or authorities (1)

The debate on each of the two topics was introduced by a political report presented by Mr Bernard Dupont, Swiss National Councillor, and Mr Flavio Cotti, Councillor of State, member of the State Council of Ticino, respectively, and based on technical reports submitted by the CDRM.

- 7. The very lively conference debates undoubtedly had a political flavour which seemed to inspire genuine commitment on the part of the Ministers. In their interventions and the conclusions on the first theme they underlined the importance they attached to local autonomy as an essential part of the European democratic system and stressed the role of the Council of Europe in this sphere. A number of speakers described a possible European Charter of Local Self-Government as the «fourth pillar» of the Council of Europe.
- 8. The Colloquy between the Ministers and Representatives of the Assembly and of the Conference of Local and Regional Authorities of Europe (CLRAE) which took place on 6 October 1982, was particularly lively. It dwelt mainly on the draft Charter of Local Self-Government submitted by the CLRAE (Resolution 126 (1981)) to the Committee of Ministers. The 12 members of the conference present at the colloquy, supported by the representative of the Assembly, undoubtedly did much to persuade the majority of the conference to adopt a favourable attitude towards the idea that the Charter of Local Self-Government should take the form of a convention, despite certain reservations on this matter expressed by a number of speakers.

- 9. The Ministers requested the Committee of Ministers of the Council of Europe to instruct the Steering Committee for Regional and Municipal Matters (CDRM) in contact with the CLRAE, to make the necessary changes to the draft charter submitted by the CLRAE, in accordance with the comments concerning the form and the substance made during the conference, so that it could be submitted to them for approval at their next conference in Rome in 1984.
- 10. With regard to the second theme: the state of transfrontier co-operation between territorial communities or authorities, the Ministers noted with satisfaction that progress had been made towards the implementation of the European Outline Convention on Transfrontier Co-operation between Territorial Communities or Authorities and expressed the wish that ratification by the other countries should be carried out as soon as they were able to do so. A number of forthcoming ratifications were announced (1).
- 11. The Ministers asked that the political reports presented on the two themes by MM Dupont and Cotti should be referred to the CDRM for examination.
- 12. At the end of the conference the Ministers expressed their appreciation of the excellent way in which it had been organised. They accepted the invitation of the Italian Government to hold the next session of the conference in Italy in 1984, «to decide upon the draft Charter of Local Self-Government and to discuss the relationships between the various levels of local administration under a regional organisation». (See conclusions last sentence).
- 13. With regard to the interest aroused by this conference and its impact on public opinion, it should be noted that newspaper and agency articles, together with radio and television broadcasts, were very numerous in some countries and bear witness to excellent press coverage.

SUGGESTIONS FOR FURTHER ACTION

A. THEME I (Local autonomy)

- 14. Item I (i) of the conclusions on this theme reads as follows:

 «/The Ministers/ ask the Committee of Ministers of the Council of Europe
 to instruct the Steering Committee for Regional and Municipal Matters (CDRM),
 in contact with the Conference of Local and Regional Authorities of Europe,
 to make the necessary changes to the draft European Charter of Local SelfGovernment in accordance with the comments concerning the form and the
 substance made during the conference, so that it may be submitted to them
 for approval at their next conference.»
 - 15. The Secretariat will take account of this ministerial recommendation in the working paper (CM (82) 203) to be prepared by the Plan and Programme Division for the examination of the draft 1983 Programme of Activities (addendum to CM (82) 149). The Deputies will be requested to approve an amended text of Activity 20.1.5.

16. The Deputies are invited

- i. when adopting the 1983 Intergovernmental Programme of Activities to respond favourably to the wish of the ministerial conference by approving Activity 20.1.5;
- ii. to transmit the report presented by Mr Dupont to the conference to the CDRM so that it is examined and taken into account when Activity 20.1.5 is being prepared and also when proposals relating to the Medium-Term Plan and the Intergovernmental Programme of Activities are being drawn up.
- B. THEME II (Transfrontier co-operation)
- 17. The conclusions relating to this theme do not call for any specific action. Accordingly, reserve Activity 20.6.2, which had initially been provided for in the draft 1983 Programme of Activities (see CM (82) 149 add.) as a possible follow-up to theme II of the Lugano Conference, need not be considered further. The Deputies are invited to take a decision to that effect when they examine the draft 1983 programme.
- 18. It should be pointed out, however, that the conclusions adopted by the Ministers refer to the recommendations adopted at the second conference (Athens 1976) on transfrontier co-operation. Furthermore, the Ministers expressed the wish that the report presented to them by Mr Cotti, should be submitted to the CDRM for examination.
- 19. In the light of what has been said above, the Deputies might agree to transmit the report presented by Mr Cotti to the Lugano Conference to the CDRM so that it is examined and taken into account when implementing its activities, particularly that concerning the European Outline Convention on Transfrontier Co-operation between Territorial Communities or Authorities.

C. PREPARATION OF THE 6TH CONFERENCE

- 20. The final item of the conclusions of the ministerial conference at Lugano reads as follows: «/The Ministers/ gratefully accept the invitation of the Italian Government to hold the next session of the conference in Italy in 1984, particularly to decide upon the draft Charter of Local Self-Government and to discuss the relationships between the various levels of local administration under a regional organisation.»
- 21. Accordingly, the Secretariat has amended (see CM (82) 203) the wording of Activity 20.1.6, provisionally included in the draft 1983 Programme of Activities (add. to CM (82) 149). The Deputies are invited to adopt the new wording of Activity 20.1.6 when examining the draft programme.
- 22. Lastly, it is suggested that the Deputies might instruct the Secretary General to transmit the conclusions of the 5th Conference of European Ministers responsible for Local Government for information to:
 - the Assembly of the Council of Europe
 - the Standing Conference of Local and Regional Authorities of Europe
 - the European Conference of Ministers responsible for Regional Planning
 - OECD
 - the Commission of the European Communities.

APPENDIX IV

CONCLUSIONS ADOPTED BY THE 5TH CONFERENCE OF EUROPEAN MINISTERS RESPONSIBLE FOR LOCAL GOVERNMENT

(Lugano 5-7 October 1982)

The European Ministers responsible for Local Government, meeting in Lugano from 5 to 7 October 1982;

- 1. Convinced of the fundamental importance of the municipalities as an institution in European society;
- 2. Noting that democracy in municipalities functions at human scale, at a period characterised by a certain sense of anonymity in political and social life and sometimes by alienation of citizens from political and social life;
- 3. Convinced that local autonomy is a fundamental freedom indispensable to democratic systems at both national and European level;
- 4. Conscious of the role of the Council of Europe as a guardian of democratic principles and human rights and believing that it is the task of the Council of Europe to preserve and develop this fundamental heritage;
- 5. Paying tribute to the efforts and achievements of the Council of Europe in establishing European co-operation between local and regional authorities and their involvement in the integration of Europe;
- 6. Adopted the following conclusions:
- I. As regards local autonomy

The Ministers,

- Underline that local autonomy is an essential part of a democratic system of government and stress the role of the Council of Europe in this sphere;
- b. Note that the growing complexity of modern administration, the striving for efficiency and the systematic transfer of decision-making from local authorities to other entities, in certain countries, are constant pressures which threaten to erode the scope of local autonomy;
- c. Believe that the defence of local autonomy is part of efforts made in several European countries to decentralise the management of public affairs and to bring it as close as possible to the people;

- d. Consider that the defence of local autonomy does not imply opposition to the role of the state in providing some services or regulating the economy;
- e. Believe that the decentralisation to regional powers which can be seen in several European countries must follow the principle of subsidiarity stated at the Lisbon Conference in 1977 that «Administrative functions must be entrusted to the level closest to the people, a higher level coming into the picture only if the functions cannot be co-ordinated or performed at the next level down»;
- f. Recognise that local autonomy implies that local authorities must be given the means enabling them to exercise effectively their powers;
- g. Congratulate the Conference of Local and Regional Authorities of Europe (CLRAE) for having drawn up in its Resolution 126 (1981) a draft European Charter of Local Self-Government;
- h. Consider that this draft charter constitutes an important step towards a definition of the principles of local autonomy, while noting the reservations of some Ministers about the need for a charter in the form of a binding convention and about some aspects of the content of the Charter;
- i. Ask the Committee of Ministers of the Council of Europe to instruct the Steering Committee for Regional and Municipal Matters (CDRM), in contact with the Conference of Local and Regional Authorities of Europe, to make the necessary changes to the draft European Charter of Local Self-Government in accordance with the comments concerning the form and the substance made during the conference, so that it may be submitted to them for approval at their next conference.
- II. As regards transfrontier co-operation between territorial authorities

 The Ministers,
- a. Note with satisfaction that, in accordance with the recommendation which they adopted at their Athens Conference in 1976, the Committee of Ministers has adopted the European Outline Convention on Transfrontier Co-operation between Territorial Authorities or Communities which was opened for signature in Madrid in May 1980 and came into force on 22 December 1981;
- b. Welcome the fact that 11 member states of the Council of Europe have already signed the convention and that six of them have deposited the instruments of ratification;
- c. Express the wish that ratification by the other countries should be carried out as soon as they are able to do so.

The Ministers welcomed the opportunity afforded to them, on the initiative of their Swiss colleague, Mr Pierre Aubert, of conferring in Lugano on the themes of local autonomy and the state of transfrontier co-operation between territorial communities or authorities on the basis of the excellent reports by MM Dupont and Cotti which they wished to see submitted to the CDRM for examination. They conveyed their heartfelt thanks to the Swiss authorities for the perfect organisation of the conference and their warm hospitality.

They gratefully accepted the invitation of the Italian Government to hold the next session of the conference in Italy in 1984, particularly to decide upon the draft Charter on Local Self-Government and to discuss the relationships between the various levels of local administration under a regional organisation.
