# Update on the activities of the Information Point of the Council of Europe in Belarus in 2014-2015

Document prepared by the Directorate of Political Affairs

## Item to be considered by the GR-DEM at its meeting on 7 July 2015

#### Introduction

On 23 May 2013, the Directorate of Political Affairs prepared at the request of the Committee of Ministers an overview of activities of the Information Point of the Council of Europe in Belarus (document DPA/Inf(2013)6).

On 18 June 2013, the Rapporteur Group on Democracy took note of this document and gave guidance to the Secretariat on the launch of the procedure for the renewal of the agreement between the Council of Europe and Belarus on the Information Point in Minsk for a two-year period.

The renewal for a two-year period of the International Technical Assistance Project entitled "Functioning of the Council of Europe Information Point in Minsk 2014-2015" was agreed with the Belarusian State University (BSU) as the main partner of the Project. It was then submitted to the Belarusian authorities in October 2013 and registered by them on 24 February 2014.

The on-going Project "Functioning of the Council of Europe Information Point in Minsk in 2014-2015" has an implementation period until 31 December 2015 and it is financed for this period by voluntary contributions of Luxembourg and Norway.

#### Mandate of the Information Point in 2014-2015

The aim of the Information Point is to raise awareness of government institutions, non-governmental organisations, mass media, educational establishments, students and citizens of Belarus and to provide them with information on the fundamental values, legal instruments, achievements, policies and activities of the Council of Europe, by means of:

- organisation, implementation and support of a large spectrum of Council of Europe events, including, among others, lectures, seminars, round tables, conferences, thematic competitions and exhibitions, etc.;
- translation, publication and distribution of Council of Europe information materials ;
- improvement of the functioning of the Information Point library and development and promotion of the Information point website;
- organisation and support of visits of representatives of the Council of Europe to the Republic of Belarus and of representatives of the Republic of Belarus to the Council of Europe;
- dealing with information requests from public organisations and citizens.

#### **Overall objective**

The policy of engagement through the Information Point has continued in 2014-2015 and the functioning of the Information Point in Minsk during this period contributed within its mandate to raise the awareness of Belarusian society of the fundamental European values. All activities were envisaged with the aim of promoting the Council of Europe's statutory principles of respecting human rights, democracy and the rule of law amongst various groups of population and officials.

In 2013, for the first time and further to the proposal of the Council of Europe's Secretariat, the Belarusian authorities prolonged the presence of the Information Point in Minsk for two years, for 2014-2015. This development helped to better ensure the sustainability of Information Point action than during the previous one-year project. It also gave an opportunity to align the functioning of the Information Point with the Council of Europe's bi-annual programming and financial cycles.

#### Specific objectives

As regards its specific objectives, the Information Point proceeded with the organisation, implementation and support of various Council of Europe events in Belarus. The complete list of activities, as well as their results, appears in **Appendix I**, including the activities planned until December 2015.

Moreover, awareness-raising of the Council of Europe has been consolidated through the organisation and support of visits of Belarusian representatives to the Council of Europe (academics, students, youth, media experts, civil servants and representatives of civil society). This Information Point action gave an opportunity to students and representatives of specialised sectors to have more regular contact with the Organisation. These visits gave the opportunity to representatives of the public sector and of the authorities to have closer contact with representatives of the civil society. This was particularly evident during the preparatory stage of the visits of legal experts and Belarusian journalists to the Council of Europe.

Council of Europe materials have been disseminated at all events held in 2014-2015. Moreover, the Information Point Communication Officer participated for the first time in the web-broadcast of a live public discussion on the death penalty organised by the NGO "Office of European Expertise and Communications" on the occasion of Human Rights Day.

In 2014-2015, the Information Point continued to remain a Council of Europe transversal project involving various sectors and institutions of the Organisation. The Information Point organised and/or supported a series of visits of Council of Europe representatives to Belarus. Experts from the following Council of Europe member States contributed to the activities of the Information Point: Armenia, Azerbaijan, Belgium, Bosnia and Herzegovina, Denmark, France, Georgia, Hungary, Latvia, Lithuania, Montenegro, Republic of Moldova, Poland, Portugal, the Russian Federation, Serbia, Switzerland, Ukraine and the United Kingdom.

Among highlights and specific achievements of the Information Point action in the reporting period, special reference should be made to:

- the work of the Information Point in supporting Council of Europe-Belarusian dialogue related to the accession of Belarus to the Bologna Process;
- co-operation with the United Nations and the Belarusian authorities on "National Human Rights Institutions: Establishment and Functioning";
- assistance with the visits of representatives of the Council of Europe to Belarus;
- organisation of the CoE-OSCE/ODIHR conference on "gender equality and participation of women in public life";
- UN/Council of Europe/Raoul Wallenberg Human Rights competition (36 and 84 youngsters from all over Belarus took part in this competition respectively in 2013 and 2014);
- launch of the preparations for a Belarusian team (BSU) to participate in the 2016 René Cassin European Human Rights Competition.

During this period and for the purpose of the implementation of the activities carried out and facilitated by the Information Point in Minsk, strong interaction was maintained between the Secretariat and the Belarusian State University as the national implementation partner. Contacts with civil society, the international community in Belarus and other interlocutors have been constant and constructive.

#### **Communication and visibility**

The strategy of 2014-2015 has been oriented on four axes:

- Preparation of the new website of the Council of Europe Information Point: <u>http://www.coe.bsu.by/index.php/en/;</u>
- Organisation of a series of presentations on the Information Point in the regions, with distribution of the Council of Europe publications (Slutsk, Vitebsk, Grodno, Brest, Uzda);
- Regular and active participation in public events organised by partners (ex. NGO "Penal Reform International" on the occasion of the International Day against the Death Penalty);
- A series of study visits to the Council of Europe for Belarusian journalists with the aim of extending their knowledge about the Organisation.

The participation of Mr Makei, Minister for Foreign Affairs of Belarus, in the Council of Europe round table "Topical issues of Belarus-Europe relations" (Minsk, 31 October 2014) gave an additional impetus to the visibility of the work of the Information Point in the Belarusian media.

#### **Observations on project management**

*Information Point staff in Minsk:* The Information Point continues to be hosted in the BSU premises and from the legal point of view it functions as an entity of the University. The Communication Officer and the Administrative Assistant have work contracts with the BSU.

*Challenges, Lessons Learned and Follow-Up:* a number of challenges of an organisational and financial order were met during the implementation period. Firstly, due to the complexity of national procedures for registration, formalities should be finalised well in advance. Secondly, due to the fact that the Information Point is not a separate legal entity and functions as an entity of the Belarusian State University, it cannot proceed - by virtue of national legislation - with a number of financial and logistical operations. This obstacle concerns in particular the organisation of larger-scale events in the regions, the participation of regional participants in Minsk-based events, the organisation of study visits to the Council of Europe for target groups not linked to the BSU, as well as technical distribution by the Information Point of the materials published inside Belarus by other entities with the financial support of the Council of Europe. As a consequence, a number of activities in 2014-2015 had to be organised logistically and financially directly from the Headquarters with limited staff resources assigned to the Project.
