Deputies between 4th -6th June 2013, we kindly request that you bring to the attention of the Members of the Committee the fact that, despite our repeated calls upon Turkey to effect payment of the amounts awarded by the European Court of Human Rights to our clients as just satisfaction, to date Turkey has systematically denied to repay the total amounts, plus default interest, due and owing to them.

In particular, the following amounts have been duly awarded to our clients by the European Court of Human Rights and have yet to be settled by Turkey:

Turkey: The amount of 12.000,00 Euro per Application in respect of non-pecuniary damage, and 8.000,00 Euro per Application in respect of costs and expenses, plus interest from the expiration of the three-month period from the date of the final Judgment, i.e. 18.09.2009, until full and final settlement thereof;
