**Meeting report** 

## 1. Opening, agenda, election

1. The Committee of Experts on Media Pluralism and Transparency of Media Ownership (MSI-MED) met in Strasbourg on 22nd and 23rd March 2016. The meeting was opened by Mr Jan Kleijssen Director, Information Society and Action against Crime Directorate.

2. The MSI-MED unanimously elected Ms Helena Mandić and Mr Evangelos Valmas as respectively Chair and Vice-Chair and appointed Ms Maja Zaric as gender-equality rapporteur.

3. Thereafter the meeting was chaired by Ms Helena Mandić. The Committee adopted the agenda (Appendix II).

## 2. During the meeting, the MSI-MED took the following decisions:

It took note of the <u>Terms of Reference</u> and of <u>Resolution CM/Res(2011)24</u> on intergovernmental committees and subordinate bodies, their terms of reference and working methods.

It took note of the two draft working documents (annex) prepared by the Secretariat and decided that these can be used as a basis for MSI-MED.

## 3. Working methods

The two MSI-MED drafting groups have been constituted as follows:

1. For the draft recommendation on media pluralism and transparency of media ownership, the group consists of Mr Evangelos Valmas, Ms Elda Brogi, Ms Natalie Fercher, Mr Tarlach McGonagle and Mr Damian Tambini. Mr Michael Wagner, EBU Observer,

volunteered to participate in the drafting process with regard to Public Service Media and his participation was welcomed by the Committee.

Mr Tarlach McGonagle was designated as the main editor for the draft.

2. The MSI-MED decided that the two components of their second task, namely the feasibility study on the use of Internet in elections and the gender equality in the context of media coverage of elections, will be dealt with separately. The drafting group for the two feasibility studies consists of Ms Helena Mandić, Ms Maja Zaric and Mr Pierre Francois Docquir.

## 4. Structure and content of the documents to be produced

Regarding the draft recommendation on media pluralism and transparency of media ownership:

The MSI-MED agreed to provide, in the Preamble, general principles and a short explanation on the recent developments in the media landscapes in order to match the principles with current reality. It further agreed to give reasons for dealing with media ownership transparency and media pluralism in one systemic approach. MSI-MED discussed during the second day in detail on the basis of a preliminary draft of the preamble presented by Mr Tarlach McGonagle.

Based on the issue mapping non-paper that had been prepared by the Secretariat, the MSI-MED discussed the desired outcome and the possible structure of the recommendation. It chose to take a holistic approach and to have freedom of expression and media pluralism as the main perspective of the recommendation as well as to divide the operative part into seven sub-themes: 1) Media ownership transparency 2) Media literacy/education 3) Independence of regulatory bodies 4) Public service media 5) Media concentration 6) Editorial independence 7) Media diversity.

Considering that Internet intermediaries and platforms play an important role in the distribution and circulation of media content (including through the use of algorithms that influence the visibility of media content), the MSI-MED will coordinate with the work of the MSI-NET.

The MSI-MED agreed on an approach that is directed towards the practical implementation of the recommendation.

The MSI-MED agreed on the inclusion of an appendix to the recommendation with all the relevant documents.

Regarding the feasibility studies:

The MSI-MED agreed that for the study on the use of Internet in elections, the scope will be mapped out taking into account also the MSI-NET committees' work. MSI-MED tends to focus on the political advertising on internet and the integrity of electoral process. Following the discussions, MSI-MED agreed that Mr Damian Tambini will prepare a short note as a

proposal of scope. MSI-MED noted that an external consultancy may be needed for this study.

As regarding the study on gender equality in the context of media coverage of elections, there has been broad consensus to focus on the portrayal of women in media during election campaigns. The committee has noted that the draft working document was already very detailed on this topic.

## 5. Any other business

The MSI-MED took note of the information provided by Mr Rüdiger Dossow, from the Secretariat of PACE Committee on Culture, Science, Education and Media and by Mr Pierre Garrone, from the Venice Commission Secretariat and welcomed future co-operation.

The MSI-MED noted that the Observatory will make available to them some restricted research documents and co-operate actively with them.

The MSI-MED decided to hold its next meeting in Strasbourg on 27th and 28th September 2016.

The MSI-MED decided that the Secretariat will prepare a draft meeting report to be sent to the Chair and the Vice-Chair for consideration. Thereafter the Secretariat will send the draft report to the MSI-MED with a deadline of five full working days allowing for comments. In the absence of comments within the deadline, the report will be deemed adopted by the MSI-MED and will be transmitted to the CDMSI.
