- to suggest recommendations on possible solutions to this problem so to ensure effective domestic mechanisms for the protection of persons affected by the conflict, as well as to prevent applications to the ECtHR;
- to provide Ukrainian stakeholders with the expert opinion on the situation and the information on the European practices in similar situations.
