**SUPERVISION CLOSED - MAIN REFORMS ADOPTED\*\*****> Fairness of judicial proceedings - Criminal charges**

**Reinforcement of the procedural safeguards in criminal proceedings in the context of arrests under European Arrest warrant:** the right of access to a lawyer as from the first police questioning and prior to first audience before the investigating judge was granted.

**> Length of judicial proceedings**

**Organisational measures reducing the length of criminal proceedings;** reinforcement and reorganisation of the Judicial Police Service; improvement of the coordination between police and judicial authorities notably through the holding of regular meetings between them; increase of the staff of prosecutors and investigating judges.

**Compensation for the administration's dysfunction** may be requested on the basis of the Civil Code or the special Act 1988.

**> Functioning of justice**

**Reform of the proceedings before the Court of Cassation addressing the problem of excessive formalism:** simplification and clarification of the formal requirements to lodge an appeal; the Court now takes into account the merits of the request to rule on the case and not only the arguments raised by the applicant.

**> Protection of property rights and freedom of association**

**Revocation in 2011 of the mandatory inclusion of landowners in hunting associations;** landowners opposed to hunting on their land may, under certain conditions, request termination of their membership of a hunting association with the consequence that their lands will not be used for hunting.

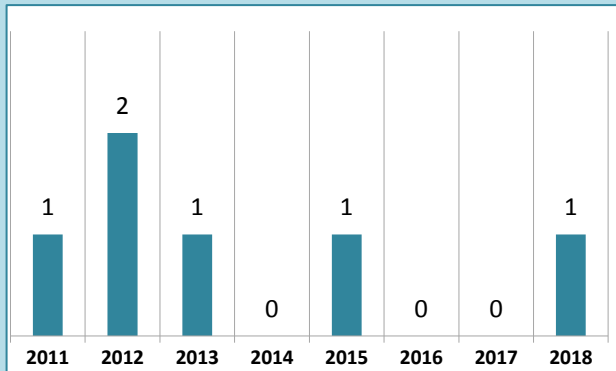

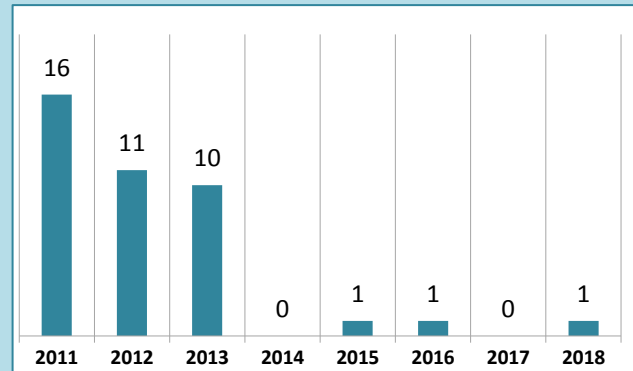

### New cases

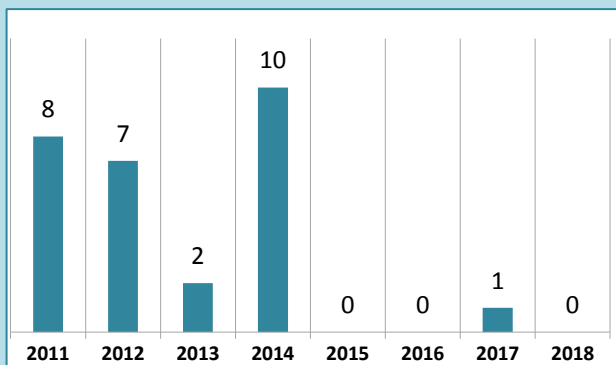
(judgments transmitted for supervision of their execution during the year)



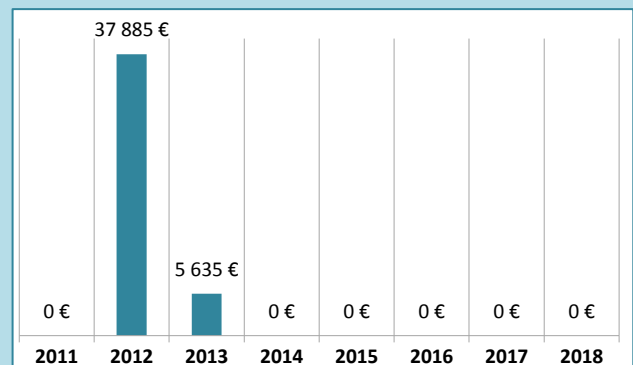
### Total of pending cases
