#### 3. Council for Penological Co-operation (PC-CP)

# a. Draft Recommendation on guidelines to agencies providing probation and aftercare to offenders

The Bureau noted that the PC-CP's second examination of the draft Recommendation had been postponed to next meeting (23-25 February). It instructed the PC-CP to send out after their meeting in May 2009 the text of the draft Recommendation and its explanatory memorandum to all CDPC delegations for their written comments in order to be able to amend the two draft texts accordingly at the PC-CP meeting in September 2009. The Bureau further took note of the conclusions of the general rapporteur of the European Conference of Directors of Probation Services and decided to forward them to the PC-CP for consideration.

# b.Recent and forthcoming work of the Council of Europe related to penitentiary issues including probation

The Bureau took note of the document "Current and future priorities and activities of the PC-CP", as updated by the PC-CP and of the information provided by the Secretariat regarding the PC-CP's priority activities for 2009-2010. It endorsed the proposal to give priority to the activities related to foreign prisoners and overcrowded prisons. It therefore instructed the PC-CP to start examining these two important matters already in 2009, if possible, and report to the PDPC on the outcome of its work.

The Bureau noted that the 15<sup>th</sup> CDAP Conference will be held on 9-11 September 2009 in Edinburgh and that the theme would be "Overcrowded prisons: looking for solutions".

The Bureau took note of the finalisation of the 2007 SPACE I survey.

It further took note of the evaluation of national replies to the questionnaire on juvenile offenders.

Finally, the Bureau instructed the PC-CP to examine possible ways for an effective implementation of EPR by the member States.

### 4. Conferences of the Council of Europe Ministers of Justice

a. Follow-up of the 28<sup>th</sup> Conference (25 – 26 October 2007, Lanzarote, Spain)

The Bureau took note of the summary of the replies to the questionnaire related to the relationship between asylum procedures and extradition procedures as well as information provided by the Secretariat on this matter.

As regards the draft Specific Terms of Reference of the Group of Specialists on Child-friendly Justice (CJ-S-CH), the Bureau decided to take note of its final version, as adopted by the Committee of Ministers. It further noted that six specialists of the Group and its Vice-Chair will be appointed on the basis of candidatures proposed by the CDPC Heads of delegations.

Finally, the Bureau took note of information provided by the Secretariat related to the future work of the Group.

### b.Preparation of the 29<sup>th</sup> Conference (17 – 19 June 2009, Tromsø, Norway)

The Bureau congratulated the PC-S-CP for the work carried out by the group of experts, and in particular Mr Claude Debrulle for his excellent chairmanship.

The Bureau also decided to give authorisation for negotiations of the draft Convention, as revised by it, to begin at intergovernmental level in the Ad Hoc Committee on Counterfeiting of Medical Products and Similar Crimes involving Threats to Public Health (PC-ISP). In this context, it appointed Mr Hans-Holger HERRNFELD (Germany), as representative of the CDPC in PC-ISP meetings.

It instructed the Secretariat to prepare a document highlighting key issues in the Convention in order to facilitate the negotiations and to provide the PC-ISP with a record of the exchange of views held by the Bureau on the draft Convention.

The Bureau further instructed the Secretariat to take all appropriate measures allowing for the continuity between the work already undertaken by the PC-S-CP and the future work of the PC-ISP.

As regards the provisions of the draft Convention on international co-operation, the Bureau instructed the Secretariat to consult the PC-OC, as well as to consult the T-CY on the relationship of the draft Convention with the Convention on Cybercrime.

The Bureau invited the Secretariat to indicate in the convocation letters that it would be useful for the discussions if States appointed more than one representative, due to the multidisciplinary approach of the draft Convention and instructed the Secretariat to continue the dialogue with other interested intergovernmental and supranational organisations, notably the European Union and the World Health Organisation with a view, where appropriate, to encourage their presence as observers in, or participation in negotiations of the PC-ISP.

Finally, the Bureau instructed the Secretariat to keep it informed about the progress made in the negotiations in the PC-ISP.

#### 6. Violence against women/Domestic violence

The Bureau took note of the terms of reference of the Ad hoc Committee on preventing and combating violence against women and domestic violence, as adopted during the meeting of the Committee of Ministers on 10 December 2008.

It also took note of the information provided by the Secretariat concerning the state of preparation of the first meeting of the Committee, which will be held on 6-8 of April 2009.

The Bureau decided to appoint Ms Maria GAVOUNELI, Mr Branislav BOHÁČIK and Mr Christian MANQUET, as representatives of the CDPC in the Committee.

The Bureau took note of the agenda of the forthcoming meeting of the T-CY and of the summary of replies to the questionnaire on mutual legal assistance in computer-related cases provided by the Secretariat. It decided to appoint Mr Hans-Holger HERRNFELD, as representative of the CDPC in the T-CY meeting of 12 and 13 March 2009.
