# National seminar on Global/Development Education in Bulgaria

25-27 September 2009 in Sozopol

#### Short background of the Bulgarian situation

GE/DE as a special field in Bulgaria has started to develop in the nineties in somewhat different ways. In the field of formal education mainly the problems has been developed as a part of Human Rights, Civic Education, Geography, Economics, Environmental Education curriculum and to a certain degree some of the content of DE/GE have been incorporated into National Educational standards .In the field of Non-formal education GE/DE problems have been introduced by many international or national projects focused on Human Rights, environmental, problems, interethnic relations, poverty and social justice problems.

By the beginning of 2000 the new impetus had come from the growing interest in the ideas of sustainable development and as well from the emerging role of Bulgaria as a member of the international community – mainly as a part of the EU. Crucial was the support of Intergovernmental organizations like UNICEFF, UNDP, and UNESCO for focusing the efforts on GE/DE problems. With the institutional support of EU National platform of DE had been established and first projects on DE with Bulgarian participation had been realized under the EU calls of proposals in this field.

There is a lot of projects and initiatives realized under the shield of DE/GE but still in the country lacks a policy in the field, lack of any coordination of the efforts of the different actors, lack of coordination or joint actions between the stakeholders. Public awareness of DE/GE is also a problem- it is not possible to have built this awareness without pro-active policy on behalf of the state and of the stakeholders, without enough institutional support.

#### Aim & objectives of the meeting

- To explore the context of Development Education and raising public awareness in Bulgaria on the basis of the Strategy approved by EU and on the other International documents and to prepare general assessment of the DE/GE situation and to elaborate a Strategy for DE/GE Education and based on the Strategy Plan of Action;
- To establish working relationships between the organizations and institutions working in the field of GE/DE - at local, national as well as European level;
- To explore the opportunities for development of regional and community DE/GE educational programs and campaigns;
- To get an agreement on the place of DE/GE in the present curriculum and to elaborate the outlines for a new approach for promoting DE/GE in Formal and Non-Formal Education;
- To develop a comparative perspective on the DE/GE developments based on the analysis of DE/GE in the neighbouring EU countries – Greece and Romania and on the developments in the old members of EU.

25-27 September 2009 in Sozopol, Bulgaria (approx 50 kilometres from the international Bourgas airport).

Bulgarian and interpretations to/from English for the foreign participants.

The experts from Romania and Greece are selected because of the need to have a comparative perspective on DE/GE problems and developments from countries which are in the same situation in the field. The UK expert is invited because together with Open Education Centre a project "United Humanity. Toward a Global Citizenship" has been developed under which a an approach for teaching GE and a manual on GE has been realized so he will be able to present the perspective of the EU on DE/GE.

#### **General Rapporteur**

A General Rapporteur will be appointed – Professor Rumen Valchev who is a former Deputy Minister of Education, former reporter on the State of Environmental Education in South Eastern Europe – Kiev Conference of Ministers of Environment of COE in 2003, Global Education in Bulgaria, Romania, Albania and Macedonia in 2001, author of Development Education Project which concept note was approved on 21<sup>st</sup> of April, Chairholder UNESCO Chair on Human Rights and Culture of Peace, Bourgas Free University, co-author of the United Humanity. Manual for Global Citizenship developed under EU GRUNDTVIG Project during 2005-2008.
