SUMMARY TABLES OF REPORTING UNDER THE BERN CONVENTION

At its second meeting on 9th September 2011 the Bureau examined the response of Contracting Parties to the reporting requests by the Secretariat.

The Bureau agreed that accurate – even though concise - reporting is essential for the effective monitoring of the implementation of the Bern Convention's provisions and recommendations. It therefore instructed the Secretariat to prepare a comparative table listing the reports received by the Parties.
