**SUMMARY TABLES OF REPORTING UNDER THE BERN CONVENTION**

At its second meeting on 9<sup>th</sup> September 2011 the Bureau examined the response of Contracting Parties to the reporting requests by the Secretariat.

The Bureau agreed that accurate – even though concise - reporting is essential for the effective monitoring of the implementation of the Bern Convention's provisions and recommendations. It therefore instructed the Secretariat to prepare a comparative table listing the reports received by the Parties in 2011.
