Note Verbale

The Permanent Representation of Romania presents its compliments to the Secretary General of the Council of Europe and following Notes Verbal no.498/17.03.2020 and no.671/21.04.2020, in view of the obligation stipulated in art. 15 para. 3 (2nd thesis) of the Convention for the Protection of Human Rights and Fundamental Freedoms, has the honour to inform the Secretary General that the state of emergency on the territory of Romania have ceased to be in force as of 14 May 2020 (24:00 hrs).

The provisions of Decree no. 240/14 April 2020 on extending the duration of the state of emergency on the territory of Romania and of the military ordinances adopted on its bases which might have involved derogations from the provisions of the Convention for the Protection of Human Rights and Fundamental Freedoms have ceased their effect as of the same date.

The Permanent Representation of Romania avails itself of this opportunity to reiterate to the Secretary General of the Council of Europe the assurances of its highest consideration.
