UNITED KINGDOM

Declarations contained in a letter from the Secretary of State for Foreign, Commonwealth and Development Affairs of the United Kingdom, dated 12 July 2021, registered at the Secretariat General on 16 July 2021 - Or. Engl.

In accordance with Article 37, paragraph 2, of the Charter, the United Kingdom of Great Britain and Northern Ireland denounce acceptance of Article 18, paragraph 2, of the Charter with effect from 26 February 2022.

In accordance with Article 37, paragraph 3, of the Charter, the United Kingdom of Great Britain and Northern Ireland declares that the denunciation of the acceptance of Article 18, paragraph 2, of the Charter shall extend to the Isle of Man.
