MWL – The Mary Ward Loreto Foundation

The Mary Ward Loreto Foundation (MWL) is a non-profit organisation whose mission is to eliminate human trafficking from Albania. The foundation works to achieve this goal through a three-fold approach of advocacy, prevention, and support for PV/VoTs. Awareness raising and advocacy remain necessary to maintain public attention to the fact that such crimes continue to be committed across the country. Prevention is achieved by MWL through conducting a number of projects at the local level to facilitate systemic change and eliminate poverty, one of the main causes of human trafficking. MWL also develops programs for vulnerable communities in Albania to prevent human trafficking. Support services are provided on a referral basis to individuals vulnerable to human trafficking and abuse, as well as to returning victims, who receive specialized assistance in reintegration and rehabilitation. Mary Ward Loreto is active throughout Albania, in southern Albania (Saranda, Konispol and Lushnja), in central Albania (Tirana and Durres) and in northern Albania (Lezha, Shkodra, Rreshen, Puka, Tropoja).

Payoke, Pag-Asa, Surya

PAYOKE was founded in 1987 as the first nonprofit organization and shelter specifically for victims of human trafficking. In 1992 Payoke designed the victim orientated Belgian multidisciplinary model against human trafficking with the support of the Belgian King. In the same year the Belgian model was legally implemented and two more centers were created. Pag-Asa and Surya. Due to the founder of Payoke, Patsy Sörensen, who shortly after became a member of the European Parliament, the Belgian model with the victim orientated approach, lay at the foundation of the first European directive on Human Trafficking.

The Belgian model is based on the close cooperation between the centers, the police, the labour inspection and the public prosecutor. This means that immediately after detection, a victim is directed toward one of the three centers, who are available 24/7 for male and female – Belgian and non-Belgian – minor and major victims of Human Trafficking. From that moment on the centers provide shelter in a hidden location, a residence permit, financial support, legal support, medical and psychological support. If the prosecutor grants the formal status we start a 3 to 5 year accompaniment. Approximately 50% of all victims in Belgium are victims of economic exploitation.

On average 1.200 victims are directed towards the centers each year and approximately 150/200 victims are granted the formal status.

SOROPTIMIST INTERNATIONAL ITALY (SI – IT)

The Italian Union of Soroptimist International is a member of the European federation (SIE) and has more than 5400 members that belong to 161 Clubs, including the two recently inaugurated e-clubs of young women under 35 with a high professional profile.

Their vision and mission are the same as those of the Soroptimist International worldwide, the fight for human rights, gender equality in particular through education and empowerment of women and girls in higher fragility. Over 3000 projects have been carried out in 2020/21, even during the difficult pandemic Covid-19 period. Our actions have been strengthened by agreements and protocols signed with many governmental and non-profit institutions; among them the protocols signed with the Ministry of Justice for the support of job training for women prisoners, with the Ministry of the Interior, the State Police and the Carabinieri for the opening of over 240 rooms for protected hearings of women and girls who have suffered violence, with the Bank of Italy for the organization of financial education courses for women at risk of social exclusion, with UNICEF for the opening of over 80 Baby Pit Stops in Italian museums and libraries for breastfeeding and nursing women. To assess the economic and social impact of a decade of the Italian Soroptimist commitment, all the data have been reported in a SROI (Social Return on Investment) research on our Gender Budgeting, just published and presented to CNEL (Consiglio Nazionale per l'economia e il lavoro) in September 2021.

TZCLD - Territoires Zéro Chômeur Longue Durée

"Territoires zéro chômeur longue durée" (TZCLD) refers to an experiment initiated in 2011 and launched in France in 2017, with the aim of fighting long-term unemployment on a territorial scale. The challenge is to show that with the mobilization of an entire territory, it is possible to offer sustainable employment to all people who are permanently unemployed and wish to do so. There will be 10 such territories by January 1, 2020. Social actors (associations, unions) have asked for a second experimental law to continue the experiment. A bill to extend the experiment was unanimously adopted on first reading by the National Assembly on September 16, 2020, with a view to authorizing at least 50 new territories by 2024.
