## **19<sup>th</sup> meeting of the Steering Committee on Media and Information Society (CDMSI)**

(19-21 May 2021, via videoconference)

### **Meeting report**

The Steering Committee on Media and Information Society (CDMSI) held its 19<sup>th</sup> Plenary meeting from 19 to 21 Mai 2021 via videoconference, chaired by Ms Inge Welbergen (the Netherlands), the Committee's Chair. The list of participants and information on gender distribution appear in Appendix 2.

#### **1. Opening of the meeting**

Mr Jan Kleijssen, Director of the Information Society - Action against Crime Directorate welcomed the members of the CDMSI and thanked them for their work and commitment. With regards to the future work of the CDMSI, Mr Kleijssen introduced the 4-year Strategic Framework proposed by the Secretary General to the Committee of Ministers for the Organisation and underlined that the key areas of work of the CDMSI are also key priorities in this framework, particularly safety of journalists, hate speech and AI. Mr Kleijssen stressed the importance of the texts in process, such as the future recommendation on combating hate speech, which is a very topical issue and will contribute to standard setting in Europe and to the debate well beyond Europe. Regarding internet governance, Mr Kleijssen also recalled that there was a Memorandum of Understanding between the Council of Europe and the EU since 2011, including an agreement to refer to each other's work as it has become increasingly transversal. Finally, Mr Kleijssen stressed the importance for the Organisation and its member states to reach a consensus on the texts to be submitted to the next Ministerial Conference for adoption, as well as on the various texts being elaborated by the three sister committees MSI-REF, MSI-DIG and ADI/MSI-DIS.

#### **2. Adoption of the agenda**

The CDMSI adopted the agenda (Appendix 1), taking note of some changes in the order of business. The Chair recalled that two important outcomes were expected from this meeting: consensus on the texts of the ministerial conference and the (a first) approval of the expert committees' draft documents before public consultation/publication.

#### **3. Recent developments**

Mr Patrick Penninckx, Head of the Information Society Department (ISD), elaborated further on the 4-year Strategic Framework proposed by the Secretary General. Mr Penninckx recalled that the Secretary General's

annual report 2020 had found worrying degrees of democratic backsliding and that in the context of the global pandemic, otherwise legitimate action undertaken by national authorities has aggravated the situation in many important areas for the protection and enjoyment of human rights and democratic values. He explained that the strategic vision has been developed with a view for Member States to reverse the trend and ensure that all necessary conditions are in place to allow human rights and rule of law to flourish. In this context, the work of CDMSI's three expert committee was of crucial importance. Mr Penninckx recalled that freedom of expression and freedom of the media are key areas of work for the Council of Europe, not only within the department but also involving other sectors of the organisation such as the Venice Commission. The Council of Europe has also been working closely on these topics with the OSCE, UNESCO and the European Commission, particularly on SLAPPs and the AI package the European Commission is currently working on. Mr Penninckx recalled that a secretariat task force on freedom of expression and media had been tasked inter alia to contribute to the preparation of a new report of the Secretary General addressing freedom of expression issues (SLAPPs, media coverage of public demonstrations, audio-visual bans). Finally, he reiterated the importance of CDMSI members' work in the development of effective policies to tackle these challenges and encouraged the CDMSI to further convey the message to member states' representatives in the upcoming ministerial conference to show a strong commitment to actively contribute to the implementation of the Organisation's goals in the above areas for the years to come.

#### **4. Review of progress**

##### **4.1 Follow up to CDMSI previous work**

The CDMSI took note of information by the Secretariat on the developments related to the draft recommendation on promoting a favourable environment for quality journalism in the digital age, approved by the CDMSI in December 2019 at its 17<sup>th</sup> plenary meeting. The CDMSI took note that in March 2020, the rapporteur group of human rights at the Committee of Ministers (GR-H) had recommended that the Committee of Ministers adopt the recommendation but because of a review proposal on the text by one member state, it had been postponed until autumn. The CDMSI noted with regret informed that it was still an ongoing process and that stressed that all efforts should be made to have this text adopted by the Committee of Ministers.

##### **4.2 Co-operation with other relevant Council of Europe bodies and committees**

With regards to CAHAI, the CDMSI welcomed the adoption in December 2020 of the [Feasibility study of a legal instrument on artificial intelligence](#). The CDMSI members were informed by Ms Clementina Barbaro, Co-Secretary of the CAHAI, that the research points to substantive and procedural gaps, uneven protection levels and uncertainties affecting development and implementation of AI tools, while the main conclusion found that an appropriate legal framework would be a combination between binding and non-binding legal instruments complementing each other. They further took note that at its upcoming plenary meeting, in July 2021, the CAHAI will review the outputs produced by its three sub-working groups CAHAI-LFG, CAHAI-PDG and CAHAI-COG and provide further elements. The CDMSI was informed that a meeting was held with the European Commission on the EC AI package to look at possible overlaps and verify to which extent these two instruments were compatible; it further took note of CAHAI's close cooperation with the OSCE and UNESCO. Mr Patrick Penninckx also informed the CDMSI members of the launch in mid-June of a joint website on all the ongoing work on AI within international organisations. He also informed the CDMSI of the creation, within the Department (ISD), of a digital development unit to coordinate the initiatives taken in the field within the Council of Europe, such as the *Recommendation on the human rights impacts of algorithmic systems* or the 2019 Helsinki conference on the impacts of AI development on human rights, democracy, and the rule of law.

## **Information on the latest developments on data protection**

The CDMSI welcomed the adoption of the *Facial Recognition Guidelines* by 'the Consultative committee of the Convention for the Protection of Individuals with regards to automatic processing of personal data (Convention 108) and took note of the Declaration of the Committee of Ministers on the future role of Convention 108, as well as the ratification process of the amending Protocol of the Convention 108, which is to be further advanced. The CDMSI members also took note of the publication of a [statement](#) on 3 May 2021 by the Committee of bioethics and the 'data protection Committee' on Covid-19 vaccination, attestations, and data protection.

## **Information provided by the Secretariat, consultation on issues/documents of relevance to the CDMSI work (GREVIO, PACE)**

The CDMSI was informed by the Secretariat of the finalisation of the CDMSI comments on the *Draft General Recommendation on the digital dimension of violence against women*, and their transmission to the Group of Experts on Action against Violence against Women and Domestic Violence (GREVIO). The CDMSI was also informed of ongoing work of the PACE on the 'people's right to know', for which the Tromsø Convention is of particular relevance.

## **5. Prospects for the future work of the CDMSI**

The CDMSI was first informed, in relation to the already presented Strategic Framework for 2022-2025 proposed by the Council of Europe's Secretary General, that a longer, four-year period had been introduced as a framework for the programming, with a mid-term review envisaged to allow adjusting according to emerging challenges and/or policy decisions. The strategic Framework was still to be adopted and the final decision was to be taken by the Committee of Ministers in October 2021.

The CDMSI further took note and discussed the information provided by the Secretariat on the ongoing work on the future Terms of Reference of the CDMSI, which will take into account the priorities set for the Council of Europe Strategic Framework for 2022-2025 as well as the proposals received from CDMSI members since the plenary meeting held in November 2020. The delegates exchanged views on their envisaged main areas of work for 2022-2025 and the nature of the future deliverables. The CDMSI members further took note of the adoption of the [Resolution CM/Res\(2021\)3 on intergovernmental committees and subordinate bodies](#), amending and updating the rules governing the work of intergovernmental committees, and aiming at providing increased clarity with regard to important aspects of their operation.

## **6. Conference of ministers responsible for media and information society**

### **6.1 Preparations of the Ministerial Conference**

The CDMSI took note of the state of preparations for the [Conference](#), to take place online on 10-11 June 2021, and the programme of the event, co-organized by the Council of Europe and the Government of the Republic of Cyprus. They were informed of the high-level participation of the Conference and that it will be broadcasted, except for the ministerial roundtable. The Secretariat further expanded on the detailed programme of the first and second day of the Conference. The delegates exchanged views on ways to ensure the highest level of participation of member states and discussed in detail the expected involvement of ministers and other government representatives in the ministerial round table scheduled on the second day of the conference, as well as in the thematic discussions dedicated to the four main topics of the Conference.

## 6.2 Documents of the Ministerial Conference

After an exchange on the content of each document, the CDMSI members approved the Draft Resolution on freedom of expression and digital technologies; the Draft Resolution on the changing media and information environment; the Draft Resolution on the safety of journalists. They also revised and approved the Draft Resolution on the impact of the health crisis on freedom of expression and the Draft Final Declaration of the Ministerial Conference.

The CDMSI members agreed to forward the four approved draft resolutions and the Draft Final Declaration to member states in view of their adoption at the Ministerial conference, and noted that, upon adoption of the above documents during the Ministerial conference, an interpretative statement may be made by one member state following its inability to support some provisions of the documents of the Ministerial Conference.

## 7. Standard setting under the CDMSI

### 7.1 [Expert Committee on Freedom of Expression and Digital Technologies \(MSI-DIG\)](#)

The CDMSI exchanged views with Mr Viktors Makarovs, Vice-Chair of the Expert Committee on Freedom of Expression and Digital Technologies (MSI-DIG) and took note of information by the Secretariat on the activities of the MSI-DIG, of the report of its 2<sup>nd</sup> meeting held on 17-18 March 2021 and of the roadmap for future steps. During the meeting, the importance of internal coordination and exchange through regular meetings between the MSI-DIG and its sister committees MSI-REF and ADI/MSI-DIS was stressed, in order to align their approach and avoid possible overlaps.

The CDMSI adopted the [Draft guidance note on best practices towards effective legal and procedural frameworks for self-regulatory and co-regulatory mechanisms of content moderation](#), as finalised by MSI-DIG, and gave its agreement for the publication of the document.

The CDMSI further discussed the progress of the Draft recommendation on the impacts of digital technologies on freedom of expression. During the exchange, the committee welcomed the alignment and the complementarity of the Draft recommendation with the work of the European Commission on the Digital Service Act and members were informed that they could provide comments until the 24<sup>th</sup> of May. The CDMSI agreed to hold a public consultation on the Draft recommendation, before presenting the final revised version for possible approval at the next plenary meeting in December 2021.

### 7.2 Exchange of views with Mr Triantafillos Loukarelis, Chair of the [Steering Committee on Anti-Discrimination, Diversity and Inclusion \(CDADI\)](#)

The CDMSI held an exchange of views with Mr Triantafillos Loukarelis, Chair of the Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI) on the need for a balanced and coordinated response to hate speech, a topic of common interest for both steering committees, under examination by their joint committee on combating hate speech (ADI/MSI-DIS). Mr Triantafillos underlined that the ADI/MSI-DIS's unique set up, bringing together experts from a wide range of expertise, is an opportunity for the Council of Europe to develop a framework to combat hate speech based on the ECtHR case-law, and produce a comprehensive and balanced-based approach to combat hate speech, including in an online environment.

### 7.3. Committee of Experts on Combating Hate Speech (ADI/MSI-DIS)

Maria Run Bjarnadottir, Chair of ADI/MSI-DIS, informed the CDMSI on the outcome of the third meeting of the ADI/MSI-DIS held on 12-13 April 2021, where the experts agreed on the revised version of the text based

on the contributions received and the discussions held during the meeting. The experts and participants overall agreed on the structure and principal headlines of the future recommendation while proposing several changes within the chapters. The key issues discussed were the terminologies used throughout the document, the definition of hate speech, and the distinction between hate speech that is illegal and subject to criminal liability, illegal and subject to civil and administrative liability, and hate speech that is not illegal *per se*, but causes prejudice and hate and raises concerns in terms of tolerance, civility and inclusion, and the need to align the forthcoming recommendation with relevant ECtHR's case-law. With respect to online hate speech, the experts raised the importance of ensuring coherence between the draft recommendation and other council of Europe instruments (*CM/Rec(2018)2 on the roles and responsibilities of internet intermediaries*, the upcoming *MSI-DIG Draft Guidance Note on content moderation*), while also taking into consideration EU policy and regulations (such as the proposal for a Digital Services Act of the European Commission) and the practical experiences of Member States.

The CDMSI members were informed that they should seek to preliminarily agree on the draft recommendation text, along with its sister committee CDADI during its next plenary in June, before being launched for publication consultation in the summer. The ADI/MSI-DIS will meet in autumn to agree on the revised text and its explanatory memorandum, before presenting it to the CDMSI and CDADI for approval, and subsequently to the Committee of Ministers for possible adoption.

The CDMSI members discussed the Draft Recommendation and generally expressed satisfaction with the outcome of the text. They held an exchange of views on some specific aspects of the Draft Recommendation, particularly the differences in national legislation on hate speech and the concrete implementation of the recommendation. Other key points discussed included the different levels of hate speech and the question of provisional measures for hate speech. The CDMSI members agreed to hold a public consultation on the Draft recommendation and instructed its Bureau to coordinate with the Bureau of the CDADI and ensure that a consolidated first version of the Draft Recommendation is made available for public consultation.

#### **7.4 [Expert committee on Media Environment and reform \(MSI-REF\)](#)**

The CDMSI took note of information by the Secretariat on the latest meetings held by the MSI-REF expert committee in January and end of March 2021. The Secretariat informed the members that the three documents sent to them were the latest version dating from the meeting in March, and that any comments received during this plenary would also be integrated in the current documents. All the documents were therefore work in progress and were not up for adoption during this plenary.

On the *Draft recommendation on principles for media and communication governance*, the CDMSI took note of the information that the approach taken had been to develop principles according to which members states can effectively regulate media and communication offline and online, keeping the human rights standards of the Council of Europe but also considering that the media and communication environment has changed. The CDMSI discussed the document and raised the need to ensure transparency particularly in the context of paid content. The question of the legal value of the document was raised to which the secretariat responded that if and once adopted by the Committee of Ministers, the 15 principles listed in the appendix will acquire legal value while the explanatory memorandum will serve to provide practical advice on how States can ensure compliance and consistency in applying the recommendation.

On the *Draft recommendation on electoral communication and media coverage of election campaigns*, the CDMSI, the Secretariat highlighted several guiding elements in the drafting process, notably the shift of electoral communication to the online environment, the right of people's privacy and protection of data, the potential manipulation of voters through massive use of communication and the need to balance freedom of expression and the right to a free election. The CDMSI members welcomed the progress of the text and exchanged views on the co-regulatory approach in addressing issues of online political advertising. The Secretariat was instructed to ensure coherence and coordination with the EU on online political advertising,

and to refrain from drafting too detailed provisions which could cause difficulties in concrete implementation of the recommendation in national legislations.

The CDMSI agreed to hold a public consultation on the two draft recommendations, before presenting final revised versions for possible approval at the next plenary meeting in December 2021.

In relation to the *Draft guidance note on the prioritisation of public interest content online*, the CDMSI was informed that, during the last MSI-REF meeting in March, the experts had discussed the different approaches when it comes to defining what public interest content means. It was made clear that the expert's intent was not to make a list of public interest content, but rather to give practical tools and good practice examples to States and policy makers that could help them identify what public interest content is.

#### **8. Exchange of views with Mr Alexander Seger, Executive Secretary of the Cybercrime Convention, Head of Cybercrime Division**

The CDMSI members welcomed the presentation by Mr Alexander Seger, Executive secretary of the Cybercrime Convention Committee, Head of Cybercrime Division, on the state of play of the Cybercrime Convention which criminalise offenses by any means of computers, provide procedural powers with safeguards to investigate cybercrime and collect electronic evidence in relation to any crime, provides for international cooperation on cybercrime and evidence. The CDMSI members welcomed the development of the new protocol to the Convention on enhanced cooperation and disclosure of electronic evidence which was at its final stages of discussion. The CDMSI further took note of the information provided by the secretariat on the capacity building activities by the Cybercrime Programme Office (C-PROC).

#### **9. Council of Europe Convention on access to official documents**

The CDMSI welcomed the presentation by Ms Elvana Thaçi, Administrator, Human Rights, Directorate General Human Rights and Rule of Law, about the provisions of the Council of Europe Convention on Access to Official Documents (CETS No. 205), also known as the Tromsø Convention, the first binding international legal instrument recognising a general right of access to official documents held by public authorities. With regards to the core provisions of the Convention, the CDMSI was informed that they are built on three main principles: transparency of public authorities, self-development of people and the exercise of their fundamental rights and the public's confidence in public authorities. Any limitations to this principle of free access should be necessary and aimed at protecting a legitimate interest such as public security or the protection of the environment.

The CDMSI took note that the Tromsø Convention is open to accession by any State which is not a member of the Council of Europe or any international organisation in accordance with the requirements of Article 17 of the Convention. The Convention entered into force on 1 December 2020 with 11 parties. With regards to the monitoring of its implementation, the CDMSI was informed that two monitoring bodies had been created: the Group of Specialists on Access to Official Documents, which present reports on the adequacy of the measures in law and practice taken by the Parties to give effect to the provisions set out in the Convention and, the Consultation of the Parties which is set to meet at least once every four years to consider the reports, opinions and proposals submitted by the Group of Specialists. The parties of the Convention are currently preparing reports of the legal measures taken to implement its provisions, expected to be finalised by October 29<sup>th</sup>.

#### **10. Information from Council of Europe institutions and bodies**

The CDMSI welcomed the presentation by Ms Maja Cappello, Head of Department for Legal Information of the *European Audiovisual Observatory*, about the institutional changes relating to the Observatory and its

recent work and projects. The CDMSI members took note of information regarding the implementation of the Audiovisual Media Services Directive 2010/13/EU (AVMSD) in the 27 EU member states.

The CDMSI welcomed the information provided by Ms Anne Weber, Adviser to the *Commissioner for Human Rights of the Council of Europe*, on the recent work of the Commissioner on freedom of expression and media freedom. The Commissioner wrote a letter in March 2021 to the Prime Minister of Poland, urging the government to ensure that two draft laws concerning an 'advertising revenue tax on media outlets' and 'protection of freedom of speech of social media users' respect European human rights standards, as well as a letter inviting the Spanish authorities to amend in a comprehensive manner the Criminal Code to strengthen existing safeguards of the right to freedom of expression. The Commissioner also published a Memorandum on freedom of expression and media freedom in Hungary. Another development was the upcoming participation of the Commissioner in the Conference of Ministers responsible for media and information society. The CDMSI also welcomed the publication of three Human Rights Comments, on SLAPPs and for the entry into force of the Tromsø Convention, and on the protection of journalists covering public assemblies, issued on the occasion of the World Press Freedom Day. The CDMSI members welcomed the information that safety of journalists, freedom of expression in times of Covid and the moderation of online content are among the priority topics of interest of the Commissioner.

### **11. Internet/digital governance**

The CDMSI took note and discussed the information provided by Mr Yannick Meneceur, Head of Digital Development Unit, on the Partnership with relevant business companies and their involvement in various activities of the Council of Europe. During this exchange, CDMSI members stressed that with regards to business partnerships, it is important to take a multistakeholder approach and engage with civil society and academia as well. The CDMSI also welcomed the upcoming launch of the [globalpolicy.ai](https://globalpolicy.ai) website in September 2021, as a unique source of access to documents produced by international organisations on the regulation of artificial intelligence.

### **12. Initiatives from Member States**

The CDMSI members shared information about initiatives in member states, in particular on the (i) national strategy and legislative work related to hate speech in Armenia presented by Ms Anna Karapetyan; (ii) about the takeaways from the Conference on Artificial Intelligence and the Future of Journalism Today organised by the Portuguese Presidency of the Council of the EU and about relevant legislative developments in Portugal presented by Ms Charlotte Simões; (iii) about the Swiss Covid-19 related media support measures and a new national and international "network for digital self-determination" aiming to overcome the often proclaimed dichotomy between data-driven innovation and the respect for fundamental freedoms, provided by Ms Christiane Erkoreka and Mr Thomas Schneider; and (iv) about a Ukrainian database allowing for content sharing among audiovisual media and the methodology for monitoring gender equality in media provided by Ms Olha Herasymiuk.

### **13. Participation in relevant meetings and events**

The CDMSI took note of the information provided by the secretariat on the events organised as part of Germany's Presidency of the Committee of Ministers of the Council of Europe, in particular the online-conference "Human Rights in the Era of AI - Europe as international Standard Setter for Artificial Intelligence", the Conference "Unboxing Hate Speech: European Impulses for Respect and Solidarity on the Web" and the Webinar on the impact of Covid-19 on media freedom.

On cooperation work with institutions, the secretariat informed the CDMSI of the close cooperation on freedom of expression and media issues with the European Commission, relevant commissions of the European Parliament and the European Council. The Council of Europe is also partner with the Fundamental

Rights Agency (FRA) on the Fundamental rights Forum and joint publications have been have launched on cybercrime and data protection. The CDMSI also welcomed the cooperation with UNESCO and the OSCE Representative on Freedom of Media, including the events with the participation of the Council of Europe representatives, inter-secretariat coordination meetings and conferences held on topics such as press freedom and safety of journalists. The CDMSI was also informed on the cooperation with civil society organisations and academia, and the exchanges within the EuroDIG, with the European Federation of Journalists and the European Broadcasting Union.

#### **14. Other business.**

No other issue was raised.

#### **Observer status and application**

This item was postponed to the next meeting.

#### **Abridged report**

The CDMSI noted the dates of the next Bureau and plenary meetings, set for 26-27 October 2021 and 1-3 December 2021, respectively. Noting the absence of a quorum, the CDMSI finalised the abridged report of the meeting and agreed that in the absence of reactions by 7 June, lunchtime, it would be considered adopted.
