1. The terms of the agreement between Dorset County Council and Perenco are being strictly adhered to, and Perenco should continue to work to the highest standards;

The Wytch Farm oilfield's operating agreement with Dorset Council, the minerals planning authority, ensures:

1.1 Safety in operation and controls to ensure human and environmental health

1.2 Environmental management of areas in the estate in direct control of the company. Significant open habitat restoration has taken place; work continues. Perenco carries out a number of annual ecological surveys around its land management areas with positive results on species/diversity.

1.3 A contribution (£1,700,000) towards off-site environmental improvements in the landscape character areas affected, largely within the Purbeck Heritage Coast

1.4 Effective decommissioning and site restoration once the operation has ceased

This agreement was finalised in July 2017 and remains valid for the extent of oilfield operation (to be fully decommissioned and sites restored by 2037).

2. The extension of existing quarries or the opening of new quarries must conform to the "exceptions" principle that they should only be permitted if they do not impair the character of the Purbeck Heritage Coast as a result of any one or a combination of the following:

- the scale and duration of the project;
- the negative impact on the landscape, wildlife and the enjoyment of the area by the public or local communities;
- the practical impossibility of achieving satisfactory restoration and aftercare within a period of five years following the cessation of work;

Dorset Council has managed the extension of quarries in accordance with the exceptions principle. However, Dorset Council received a [planning application](#) for a physical extension and extension of operation at Swanworth Quarry in July 2019; this has not yet been decided.

The Dorset AONB team has advised that the Council should refuse this application due to its likely adverse impacts to the Purbeck Heritage Coast and Area of Outstanding Natural Beauty. Negotiations are ongoing.

1. Secure appropriate funding incentives for continuing environment-friendly management of the landscape.

The Wild Purbeck Partnership continues to meet to discuss work programmes to tailor for appropriate funding sources.

Additionally, the Dorset AONB Team service the panel which recommends payment from the [Wytch Farm Landscape and Access Fund](#) (the £1.7M referred to in 1.1). In 2020-2021, there were 17 live projects, 7 of which applied for funds totalling £127,191 in that year. This included 1.6km hedgerow restoration (see image 1), 0.3 ha woodland creation and 0.3 ha woodland restoration.

The [Purbeck Heaths Grazing Unit](#) works supported by the Green Recovery Challenge Fund are in full delivery within the Purbeck Heaths National Nature Reserve (NNR) with 7 cattle grids installed, many kilometres of boundary fencing restored/renewed, a sustainable tourism management plan being co-created with the sector and an engagement programme in progress. In addition, the Dorset AONB team has secured resources from central government ([Farming in Protected Landscapes](#)) to support environmentally-friendly management activity across the entire AONB (in which the Heritage Coast area lies). This will amount to over £1.1M between July 2021 & March 2024.

The Wild Purbeck Partnership continue to scan for future opportunities, including land acquisition by conservation organisations and management agreements to ensure long-term beneficial management.

2. Promote and improve public transportation and other more sustainable methods of transport, particularly near the most visited sites.

The Wytch Farm Landscape and Access Fund promotes non-car access in the eligible area. The new offroad cycle between Corfe Castle and Studland and pedestrian access from Norden (a train/bus point) to the visitor attractions of Corfe Castle remain in development.

A Sustainable Tourism Strategy is to be developed by March 2022 (see above) and will help, with a particular focus on the Purbeck Heaths area.

3. Monitor the number of visitors in order to determine its impact on the environment. A visitor management strategy should be prepared for the areas with the largest number of visitors in order to avoid any negative impact either on the quality of recreational experience or on the natural resources of the Purbeck Heritage Coast.

A visitor management strategy is being drawn up for the Purbeck Heaths National Nature Reserve (NNR – see 4b for details); this includes the ‘hot spots’ of Studland and Arne.

A wider visitor management strategy remains a planned action for the Dorset Tourism Association. During the summer of 2020, various parts of the Heritage Coast received huge visitor pressure and associated impacts after the initial Coronavirus lockdown was eased – particularly at Lulworth and Durdle Door. Dorset Council ran a campaign promoting positive behaviour from visitors; initial evaluation shows that this was impactful.

Visitor information, including messages encouraging responsible behaviour, has been installed at Kimmeridge.

4. Consider further investments towards the improvement of the habitat and landscape connectivity within the Purbeck Heritage Coast.

a) Dorset AONB continue the development of a Nature Recovery Plan for the whole AONB (to be completed by March 2022), which includes the Heritage Coast. This will develop the mapping previously undertaken for existing and potential ecological networks:

b) The new Purbeck Heaths NNR Management Plan was formally adopted by the 7 landowning partners, paving the way towards more joined-up conservation activity across that area.

c) The beaver reintroduction feasibility study led by National Trust has led to an application for a wild-release licence. This is being considered by central government, which has recently closed a consultation on beaver licencing policy.

d) Wild Purbeck Partners are considering various support mechanisms to develop a nature recovery network along the Purbeck Coast. Several contiguous landowners are supportive pending appropriate investment.

5. Promote the monitoring of the main species and habitats in the area and encourage partners to coordinate efforts and produce good quality data for the whole Diploma holding area.

a) NNR partner organisations have agreed a comprehensive monitoring programme for the NNR as part of the site’s Management Plan.

b) Feasibility studies to create a Purbeck Heaths Natural History Forum have been undertaken with further development work will be undertaken in 2022 to recruit, train and direct an army of volunteer naturalists.

6. Initiate studies focusing on the biological control of invasive alien species occurring in the Purbeck Heritage Coast, particularly the Canada goose and the sika deer, and if deemed necessary, prepare a strategic plan for their control.

These species have greatest effect on the northern part of the Heritage Coast that will form the new NNR. A Deer Management Plan is being agreed amongst the NNR partners.

3. Risk: Public finance continues to represent a risk; all conservation bodies are working hard to secure funds from alternative sources for the ongoing conservation of the Heritage Coast and

surrounding area. A national [Landscapes Review](#) has been published in 2019 and recommends strengthening both funding and legal protections for AONBs and National Parks which would benefit the Heritage Coast area. UK Government is expected to respond in early 2022.
