Objectives:

- Complete training in the field of Addictology
- Contribute to the training of workers within the framework of the national plan to fight against drug use

Population concerned: Physicians, psychiatrists, other specialists, residents and clinical psychologists.

Registration fees:

12,000 DH per year excluding taxes

Duration of training: 2 years

Teaching modalities:

- Theoretical teaching of about 300 hours (18 modules spread over 2 years)

History of drugs and drug use, classification description of drugs, classification of drug use, epidemiology of drug use, general bases of applied drug use research, etiopathogenesis and co-morbidity of drug dependence, motivational interviewing, screening and brief intervention, morbidity of drug dependence and abuse, medical treatment of drug dependence: different schools and different stages, medical treatment of drug dependence: different programs, management of nicotine addiction, prevention of abuse and dependence, risk reduction, behavioral addictions, food addictions, forensic aspects etc.

Practical training of 40 hours (minimum 2 weeks spread over 2 years) in an addictology center
