#### **Regulatory Context**

There are no specific binding regulations at the European level governing protection of privacy and data processing in the context of employment. General data protection rules apply to processing personal data in a workplace. In the GDPR employment relations are specifically referred to only in the context of the processing of sensitive personal data. More specific rules can be found in Member States' national legislations.

At the same time there are some soft law instruments containing specific rules in this respect available both in EU and CoE systems. Moreover legal professionals should also take into consideration international Labour Law instruments and of course national data protection and labour law legislations.
