- 1. The objective of maintaining the management of the park has continued in accordance with the Territorial Planning and Management Plan (PRUG) approved in 2015, Law 30/2014, of December 3, on National Parks and Royal Decree 389/2016, of October 22, approving the Master Plan for the Network of National Parks. Actions have continued to regulate public access to the National Park with the improvement of access works for visitors in the Pineta Valley with the construction of a new bridge over the Cinca River. The aforementioned bridge provides access to the new car park, designed with the delimitation of spaces for vehicles and buses. The aforementioned car park is located near the Pineta baths, which have been equipped with a new wastewater treatment plant. The works on the new Escalona visitor centre have been carried out normally and the three buildings already built and planned for administration, information and audiovisual functions can be seen. The groundwork for the construction of a new information point in Escuaín with a car park and toilets has begun. As regards the improvement of coordination and collaboration with the French Pyrenees National Park (France), we can highlight the signing of the Memorandum of Understanding between both National Parks on 13 September.
- 2. The effort to inform about the regulations regarding the access of dogs to the Ordesa and Monte Perdido National Park has continued, as well as to make visitors aware of the importance of complying with the regulations. Signage has been reinforced at all information points indicating that access with dogs to the French National Park is prohibited, even if they are on a leash. In addition, the presence of livestock in the Ordesa Valley has been marked, to inform visitors and try to avoid as far as possible any interaction between livestock and dogs.
- 3. Currently, work is being done on a Sustainable Mobility Plan for the National Park and on the review of the reception capacity in each of the valleys of the National Park with the aim of making public use and the conservation of the natural environment compatible. The main objective of the Sustainable Mobility Plan for the Ordesa and Monte Perdido National Park is to regulate access to the National Park, improving the experience and satisfaction of both visitors and the local population. A series of comprehensive and sectoral alternatives will be proposed, which aim to make visitor access to the PNOMP safer, more efficient, sustainable and satisfactory. The Sustainable Mobility Plan has an approximate duration of 2 years. The start date was April 2023 and the expected completion date is April 2025. To date, within the Sustainable Mobility Plan, the citizen participation process framed within the Sustainable Mobility Plan of the PNOMP has been completed. The citizen participation process was intended to publicise the project, collect the proposals in the diagnostic phase of the Plan, involving the general public and the territory in particular.

The participatory process has been carried out in three phases throughout 2024. Face-to-face workshops were held in the four sectors of the National Park and also online workshops. In total, 8 face-to-face meetings and 2 online meetings were held in 2 rounds of 4+1. The first round of workshops took place in February and March and the second round in May.

The objective of the first round of workshops was to present the Sustainable Mobility Plan of the PNOMP and make it known to the public, share the objectives of the Sustainable Mobility Plan and collect the specific needs and proposals of the agents involved in each sector.

The objective of the second round was to debate and delve deeper into some proposals included in the first phase that could generate greater social debate and analyse different alternatives.

On November 27, the return session was held at the Sobrarbe Region Headquarters in Boltaña, which concluded the participatory process of the Sustainable Mobility Plan of the PNOMP. In this session, a summary was presented of which proposals have a place in the PMS and which do not.

The citizen participation process has allowed an important exchange of opinions and proposals between those attending the conference (different administrations and associations, residents, businessmen, etc.) and the National Park. In total, 174 people participated in the first and second round of workshops and 212 proposals were collected, of which:

o 112 were accepted.

o 91 were partially accepted because the general idea fits into the Sustainable Mobility Plan but not some of its parts.

o 9 proposals were not accepted.

The proposals were classified into 5 groups or lines of work:

- 1- Access, access management and security (42 proposals).
- 2- Alternatives to private vehicles (57 proposals).
- 3- Parking management (50 proposals).
- 4- Information management (55 proposals).
- 5- Other proposals (36 proposals).

All proposals, whether fully or partially accepted, are related to the satisfaction of the local and visiting population, and to the principles of CONSERVATION OF THE NATIONAL PARK and SECURITY, which are the main priorities of the Sustainable Mobility Plan and the Emergency and Self-Protection Plan of the PNOMP

It is necessary to modify the Emergency and Self-Protection Plan of the PNOMP to include all communication routes and/or accesses to the PNOMP as escape routes and to ensure the proper functioning of communications in the PNOMP environment to guarantee the safety of visitors as far as possible and to deal with the management of an emergency.

Both projects, the Sustainable Mobility Plan and the Emergency and Self-Protection Plan, are closely related and many of the measures they contain complement each other and are aimed at ensuring the safety of the local and visiting population.

During 2024, the funds of the Recovery, Transformation and Resilience Plan have been managed with 3,714,800 euros in investments and 2,390,000 in subsidies for town councils and associations.
The completion of the works on the Góriz refuge, managed by the Aragonese Mountaineering Federation, located in the heart of the National Park and which serves visitors on high mountain treks or tours, deserves special mention.
