- 1. A work commission has been set up for the future modification of the Master Plan for the use and management of the Territory National Park (PRUG) approved in 2015. Works to improve infrastructure for public use in Pineta and Escuaín have begun. Work continues on the new Escalona visitor center (3,352,134 euros). Attached photos. Maintenance work has been carried out on the trail network, GR11 and others to help improve the quality of visits to the National Park. We attach photos. Collaboration with the Pyrenees National Park (France) has been strengthened in monitoring the natural environment and public use.
- 2. An awareness and communication campaign has continued to inform that within the National Park dogs must always be on a leash.
- 3. For the first time, selective garbage collection is carried out in the valleys of Ordesa and Pineta. The selective garbage collection facility in Pradera de Ordesa has been improved.
- 4. In 2022, the Master Plan for use and management has been modified to regulate the camping area near the Góriz Refuge. It works with prior reservation and guarantees the proper functioning of the purification facilities available to the hostel. Publication in the Official Gazette of Aragon is attached. Signage has been reinforced to promote compliance with the regulations.
- 3. Extraordinary next-generation European funds for a total amount of 6,104,800 euros for the next 4 years. (Recovery, Transformation and Resilience Plan, in investment a total of 3,714,800 euros and in subsidy 2,390,000 euros). In addition, in a subsidy for the Ordesa Viñamala Biosphere Reserve, whose core is the National Park, 949,000 euros in subsidy.

We continue with the commissioning of a zoological nucleus for the new facilities with the aim of launching an ex situ conservation program for the Pyrenean frog (Rana pyrenaica), with the main objective of recovering this endangered species, providing a sufficient number of healthy animals to help recover existing wild

populations in the wild. An aquaterrarium has been installed in the Torla Visitor Center for educational purposes.
