Background

The **Council of Europe (CoE) Programme for Human Rights Education for Legal Professionals (HELP)**¹ is aimed at supporting the CoE member States in implementing the European human rights standards at the national level, focusing on the European Convention on Human Rights (ECHR), other key CoE instruments, and since 2015, EU law. This is done by raising the capacities of legal professionals to apply those instruments in their daily work. Since 2019, HELP has been progressively introduced in the co-operation in the Southern Mediterranean region.

The objective of HELP is to provide high quality education on human rights to judges, lawyers and prosecutors throughout Europe and beyond. Law enforcement authorities such as police and prison staff are also targeted by HELP. Thanks to HELP courses, legal professionals can better protect human rights on a national level and keep up to date with the ever-evolving standards and case law of the European Court of Human Rights (ECtHR).

HELP is:

1. the only pan-European Network of national training institutions for judges, prosecutors and lawyers in the 46 CoE Member States.
2. an e-learning platform with free on-line courses on human rights.
3. a human rights training methodology for legal professionals.

In the framework of the HELP in the Southern Mediterranean initiative, HELP online courses have been translated into Arabic (link [here](#)), while other HELP online courses have been adapted to the specific needs of the beneficiaries and implemented at regional or bilateral level in line with the HELP training

methodology. This ensures ownership of the courses developed and peer exchange through the participation of beneficiaries from the Southern Mediterranean in the HELP Network.

[HELP in the Southern Mediterranean](#) is currently implemented as part of the [joint European Union/Council of Europe South Programme V](#) whose main objective is the enlargement of a common legal space between Europe and the Southern Mediterranean region based on key CoE Conventions and standards.

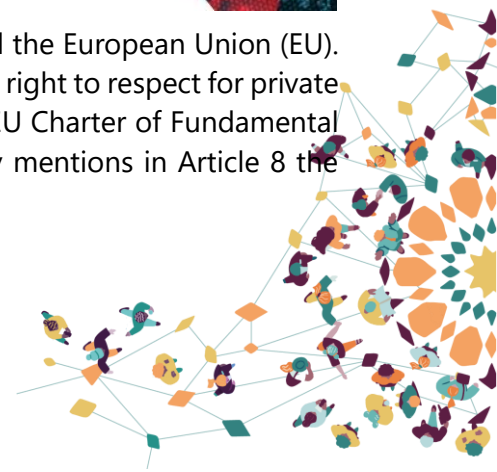
One of the priority areas of the fifth phase of the South Programme is to support its partner authorities in the Southern Mediterranean region in improving the protection of personal data. This objective is pursued through several means: the development or, where appropriate, strengthening of domestic laws on the protection of personal data, in line with international standards and in particular Council of Europe Convention 108+; providing support and capacity-building to national authorities for the protection of personal data; and fostering regional cooperation between counterpart authorities. Indeed, in an ever more globalised world, and in particular in view of international economic exchanges, it is crucial that all countries reach and demonstrate a comparable level of privacy and data protection to foster a free but safe flow of personal data and respect of individuals' human rights and dignity, which are the key objectives of Convention 108+.

It is based on the significant interest demonstrated by partners in the region and needs identified at the regional level that this Course was developed with the objective of raising awareness of international standards, building capacities of professionals in the region to better tackle this issue, while also allowing for exchanges within the Southern Mediterranean region.

Outline of the HELP course on Data Protection and Privacy Rights

People can easily become victims of data protection violations brought on by the widespread use of information and communication technologies by public and private bodies. Web-based activities, direct marketing, and video surveillance account for most violations. Even when remedies exist in civil, criminal and administrative law, enforcement is not always ensured.

The right to privacy and personal data are protected both by the legal instruments developed by the Council of Europe (CoE) and the European Union (EU). Article 8 of the European Convention of Human Rights (ECHR) guarantees the right to respect for private and family life, home and correspondence. The wording of Article 7 of the EU Charter of Fundamental Rights (EU Charter) is almost identical. In addition, the EU Charter explicitly mentions in Article 8 the right to data protection, considering it as a fundamental right in itself.



The two rights –privacy and data protection- are not absolute and may be subject to limitations. Any restrictions with regard to these rights must be made in accordance with the law, pursue legitimate aim(s) and be necessary in a democratic society.

The HELP course on Data Protection and Privacy Rights addresses this need and offers a comprehensive curriculum which covers in an interactive way the key concepts, the legal framework of the CoE and the EU (directly applicable at national level), the case law of the European Court of Human Rights (ECtHR) and of the Court of Justice of the European Union (CJEU) and specific areas of data protection. One of the key reference materials to develop this course has been the Handbook on Data Protection developed jointly by the EU FRA and the CoE together with the Registry of the ECtHR.

Existing case law on data protection and privacy rights covers topics such as medical sector, media (traditional and non-traditional), development of new technologies (i.e. GPS, drones, CCTV), e-communication and marketing, and workplace surveillance.

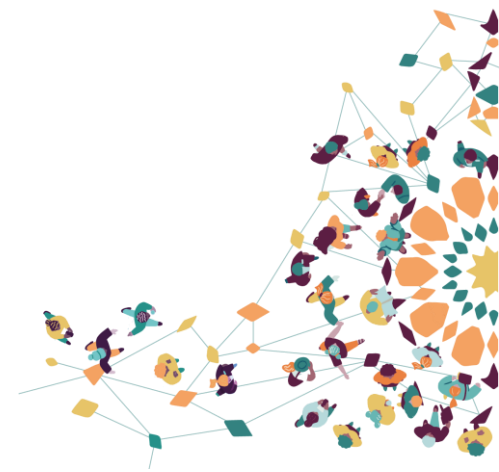

Target audience

This course is primarily addressed to representatives of data protection authorities, representatives of Government and other entities responsible for data protection and/or involved in the development of national framework for the protection of personal data. Additionally, the course can be addressed to legal professionals such as judges, prosecutors and lawyers.

The online launch

The **launch event will be held online**. Its main goal is to introduce participants to the HELP platform and the course page on which the group will follow the course with the assistance of their respective tutors. The working languages of the launch event will be **English and Arabic** with simultaneous interpretation provided. Participants will then be able to go through the tutored course in Arabic.

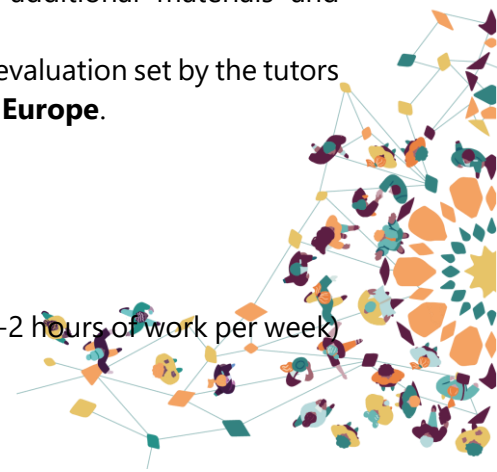

- undertake to **follow and complete the online tutored course** (approx. 1-2 hours of work per week)



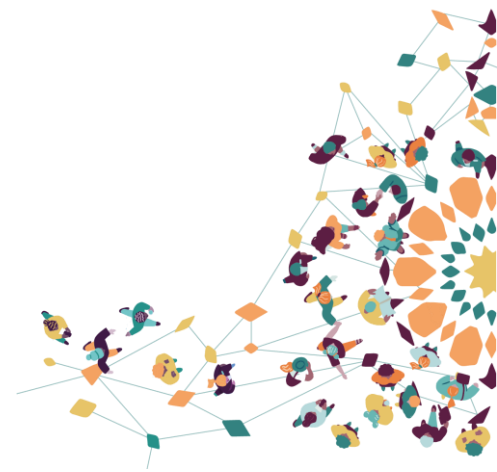
