
# **CARIBBEAN COMMUNITY AT A GLANCE**





Start a CARICOM- Council of Europe dialogue on cybercrime issues Flip the paradigm - Budapest Convention process-Do more capacity building before signing Support the inclusion of SIDS in International Expert Groups Budapest convention organisation observers ~ Cybercrime Convention Committee Champion/support need for mechanism for sharing incident and other information Documented mapping of initiatives and resources available Need to use the technologies available to support inclusion of SIDS in critical discussions \* With regards to SDG 17, the implementation and use of ICTs require coordinated partnerships in order to deliver the most appropriate and timely solutions to beneficiaries. 17.9 Enhance international support for implementing effective and targeted capacity-building in including through North-South, South-South and triangular cooperation
