About the Global Forum on Cyber Expertise

- Launched in 2015 at the Global Conference on Cyber Space in The Hague;
- Informal, low threshold, global platform for governments, International organizations,
 Private entities → currently 71 Members, 2 co-chairs (India and NL)
- Objective: identify, develop and exchange successful policies, practices and ideas on Cyber Capacity Building and to multiply these on a global level;
- Working methods:
 - GFCE initiatives bottom-up approach by and for the members;
 - Global Agenda on Cyber Capacity Building
- Support structure: GFCE Secretariat in The Hague funded by NL Government;

The importance of Cyber Capacity Building

- Cyber offers tremendous potential for Social and Economic Development
- New developments come with new challenges;
- Cyber communities need to be resilient, stable and reliable
 - → Cybersecurity measures and fighting Cybercrime

How did the GFCE evolve in the past years?


- 2015-2016 Building the network
- 2017 Shift of focus to positioning the GFCE as a coordinating platform for cyber capacity building, by developing the Global Agenda for Cyber Capacity Building;
- In 2018 and 2019, the focus of the GFCE will be to facilitate and to coordinate knowledge and expertise sharing for the implementation of cyber capacity building based on the five themes of the Delhi Communiqué.

Results

- ₱ Establishment of a strong (personal) GFCE network
- Various deliverables through initiatives (toolkits, reports, etc.)
- **Exchanging expertise** through international expert meetings and workshops
- Global online database of capacity building initiatives

- It requires concrete action.


