# **Enlarged Partial Agreement on Sport (EPAS)**

# 14<sup>th</sup> meeting of the Consultative Committee

Strasbourg, 13 June 2022 9 am - 12 pm

**Meeting report** 

# 1. Opening of the meeting

Kolë Gjeloshaj, Chair of the Consultative Committee, opened the meeting and welcomed the participants. The Chair underlined that it is the first time that so many members of the Committee are present. This not only demonstrates that the work carried out by the different stakeholders (Member states, CC members and the Secretariat) but, above all, that the themes addressed are considered extremely important by the sport community and by the relevant public authorities. He thanked the organisations which are giving their time and resources to the work on sport of the Council of Europe.

The Chair informed the Consultative Committee of the upcoming elections and the written nominations received for the positions of chair, vice-chair, bureau and gender equality rapporteur. He invited interested delegations to make any further oral nomination, before closing the application period in order to allow for the smooth preparation of the elections by the Secretariat. No further candidacies were put forward.

The quorum was confirmed by the Secretariat. The list of participants is appended to this report (see Appendix II)<sup>1</sup>.

# 2. Adoption of the agenda

The agenda as appearing in document EPAS(2022)21 was adopted (see Appendix I).

# 3. Update by the Secretariat

Irena Guidikova, Head of the Department on Children's Rights and Sport Values informed the delegations of recent developments. The Consultative Committee took note of the cessation of membership of the Russian Federation both at the Council of Europe and at the Enlarged Partial Agreement on Sport (EPAS), of the strategic priorities of the Council of Europe in the field of sport for 2022-2025, as well as changes in the Secretariat.

## 4. Revision of the new Terms of Reference of the Consultative Committee (CC ToR)

The Consultative Committee welcomed the recent amendments to the Terms of Reference, in respect of Articles 2.2 on gender equality and 3.3.b) on the need for a gender balanced composition of the Bureau of the CC.

The Chair proposed to add in article 3.3 "e) Election of the Gender Equality Rapporteur" and this proposal was approved by the CC. The Secretariat will ensure that the necessary steps for the amendment of the corresponding Terms of Reference are undertaken.

# 5. Elections

Elections had to be held for the following positions:

All candidates were given an opportunity to introduce themselves before the voting.

Laura Capranica (EAS) and Davide Delfini (GAISF) were nominated as scrutineers.

25 organisations were entitled to vote. 25 ballot papers were received (including the 2 proxies from TAFISA to IDO and UEFA to ISF)<sup>2</sup>.

#### 6. Recent events

The Chair informed the CC of the events organised since the last meeting in 2021, which include the successful webinars on 3 June 2021 (checking criminal records as a tool to protect children in sport) and on 22 February 2022 (physical education and school sport).

The Secretariat informed that attendance levels were very good (over 200 connections registered) with also very positive feedback on the format and content of the webinars. Regarding the followon, it concluded that cross-sectoral cooperation with relevant stakeholders such as judicial authorities, the police, the ministry of education is crucial to promote safe sport and school sport.

The Chair proposed that CC members be informed by the Secretariat of events organised by the Sport Division which would allow for possible engagement of CC members, with open and transparent processes in respect of the identification of those contributing.

## 7. Tour de table

The Chair invited organisations that have an event in the period up to the next Ministerial Conference to present it. Intervened among others, EAS, EFPM, ENSE, EUA, PTG. He invited these organisations to also promote their relevant activities and events during the joint meeting with the Governing Board.

## 8. CC membership

#### 8.1 Overview of the membership

The Chair welcomed the newest members of the CC: the Alice Milliat Foundation, FIBA and Panathlon International. They all participated in an induction session organised in February in order to facilitate the identification of common priorities between those organisations and the CC.

The Chair gave the floor to the representatives of those three organisations and to IFSO's which joined at the previous Joint meeting in 2021.

#### 8.2 Renewals

Renewal requests from 3 CC members (the Global Association of International Sports Federations (GAISF), the European Association for Sport Management (EASM) and the

International Dance Association) were being processed and will have to be submitted to the GB in the summer for consideration by written procedure. The Chair thanked those CC members who submitted renewal requests in a timely manner.

# 8.3 Pending application

The CC took note of the current status of the membership application by the Centre for Sports and Human Rights, attending the meeting as guest pending completion of the admission process.

The Chair finally pointed out that for the first time in the history of EPAS, with the possible granting of membership to the Center for Sports and Human Rights, the CC would reach its highest level of participation with the threshold of 30 members being reached.

# 9. Upcoming events

The Chair invited CC members to react to the draft agenda of the joint meeting with the Governing Board and share any comments they may have.

The representative of Play the Game highlighted the need to ensure that the choice of hosting countries of Ministerial conferences be made in due consideration of the human rights, democracy and rule of law situation of the countries concerned.

# **10.** Communication strategy

The CC took note of the information provided by the Secretariat.

# 11. Date and place of the next meeting

Further meeting dates will have to be confirmed, a bureau meeting will be held at the occasion of the Ministerial Meeting in October in Antalya, Türkiye, and possibly a meeting of the Consultative Committee depending on the level of attendance on site.

# **12. AOB**

No specific issued was raised.

# 13. Closing

The Chair thanked the CC members present for their active participation and as many organisations do not yet have the experience of joint meetings, he invited them to not hesitate to share their views during the meeting with the Governing Board. The Chair closed the meeting.
