- Newly formed Working Group on Vision and Strategic Plan for the Bern Convention for the period to 2030 in 2024: mandated by the Standing Committee in 2023

- 1st meeting online 10 April 2024 kick-off meeting (I)
  - T-PVS (2024) 2
  - ✓ Chair elected
  - ✓ “Follow-up of implementation of the Strategic Plan – Workplan for 2024”: the Working Group discussed Objectives 1-5 from its Terms of Reference

# Bern Convention Strategic Plan

- 1st meeting online 10 April 2024 kick-off meeting (II)
- ✓ Indicators of the Strategic Plan: members were provided with an easy-to-use template to present their feedback and the independent consultant prepared an analysis of the replies
- ✓ Dedicated webpage on the Convention's main webpage
- ✓ Workplan for 2024 adopted

# Bern Convention Strategic Plan

- 2nd meeting online 29 August 2024 (I)
  - T-PVS (2024) 08
  - ✓ The Working Group examined the feedback received in writing on proposed indicators aimed to measure progress in the implementation of the Strategic Plan and agreed on a way forward
  - ✓ The suggested follow up actions would serve as a basis for drafting a roadmap of the forthcoming WG's work

# Bern Convention Strategic Plan

- 2nd meeting online 29 August 2024 (II)
- ✓ The WG also examined a draft questionnaire for voluntary national updates on the implementation of the Strategic Plan (T-PVS/Inf(2024)12rev)
- ✓ The questionnaire aimed to understand whether the implementation of the Strategic Plan was underway and whether Parties were facing challenges
