Main principles implemented in the final Checklists

- The Checklist for Resolution No. 8 (2012) contains the agreed list of species of Resolution No. 6 (1998) and habitats of Resolution No. 4 (1996) indicating the occurrence type in each biogeographical region for 17 countries concerned.
- Principles for reducing the workload, as adopted during previous meetings, rigorously implemented
 - No reporting for marine features and marine regions: all remaining records deleted from the checklist
 - Only habitats with a 1 to 1 relationship with Annex 1 of the HD taken into account. Other habitats not to be considered
 - No reports for Birds



Species - Taxonomy

- The origin of the first version of the Checklist was the Reference List under the Emerald Network. Recent taxonomy was not yet implemented in the dataflow for the Emerald Network
- Species Scientific Names reviewed according to the list as used for Art. 17 reporting and as indicated in the Catalogue of Life (<u>COL | The Catalogue of Life</u>)
- For more details: See the appropriate sections in the Reporting Guidelines Explanatory Notes and Guidance on Concepts documents
- For countries without a reply, the Species Names are amended according to available knowledge and above indicated references. Conservative approach at this time
- In case of doubts: a comment was added to the record: e.g. Serratula tanaitica -> "likely TAX Klasea radiata subsp. tanaitica"
- Species can still be added or commented in the process of data collection, only condition is that the species has a code in the EEA species database

Species extinct prior to entry into force of the Bern Convention (EXp)	Mandatory for species with restoration project and for species of particular interest with recent signs of recolonisation			
Taxonomical uncertainty (TAX)	Mandatory			
Scientific reserve (SCR)	Optional			



Species – Population Units

- Fully standardised with Art. 17 reporting
- Species population units added to the checklist according to the principles explained in the Reporting Guidelines Concepts and definitions (section 1.6)



Overview for Habitats

- The list of possible habitats is the list of 41 habitats with a 1 to 1 relationship with annex I of the Habitats Directive (27 of them are present in the Checklists)
- X01 Estuaries are considered as Marine and are not taken into account
