1. ensure that the necessary budget and resources are available for the manifold functions and operational tasks of the Bílé Karpaty Protected Landscape Area's staff, including administration, research, surveillance and habitat management;

2. take strong measures to control non-native species in the national nature reserves and the other strictly protected areas. Continue the necessary negotiations with relevant stakeholders aiming at controlling non-native big game populations in the protected landscape area; ensure that the monitoring of the population of fallow deer in the Radejov hunting reserve is continued and regularly validated by Bílé Karpaty Protected Landscape Area staff;

3. continue to implement nature-based solutions and management in the face of climate change, ensuring the continuation of the current forestry policy of conversion to hardwood stands and encourage the natural regeneration of native hardwood forests;

4. evaluate the need, and take the necessary actions, for having a stronger presence of the Bílé Karpaty Protected Landscape Area during the preparation or review of the urban plans of the major urban areas within or bordering the protected landscape area. Additionally, identify any areas where urban development may become a risk in the near future and evaluate the necessity of drafting an urban plan for these areas (if one does not exist);

5. include the European Diploma logo and information about the European Diploma in all promotion materials produced in the future as well as in any new signposts installed in the Bílé Karpaty Protected Landscape Area.  Although there have been economic difficulties in the Czech Republic, the budget for the Protected Landscape Area (PLA) Administration has been stable. In 2024, operational budget reached CZK 1,069,000.00 (EUR 42,700.00), additional CZK 12,000,000.00 (EUR 480,000.00) were spent in the field for nature conservation and landscape management measures.

Within the PLA Administration, there currently are 30 staff members located at three workplaces (Luhačovice, Zlín and Veselí nad Moravou): at Brumov-Bylnice, the PLA Administration runs a special contact point open during office hours. Also in 2024, the Administration consists of the four departments: (i) Department of Operations; (ii) Department of Nature Conservation and Landscape Protection; (iii) Department of Nature and Landscape Management; and (iv) Department of Biodiversity Monitoring. For two more posts, selection process has been under way.

2. The Radejov hunting preserve/game park (1,600 hectares) owned by a private person is the largest private hunting preserve/game park in South Moravia and one of the largest ones across the country. The browsing and overgrazing impact of big game, particularly by the overpopulated non-native fallow deer (*Dama dama*) as well as the red deer (*Cervus elaphus*) on vegetation, especially on forest natural regeneration has been significant there. In addition, pursuant to the decision of the Supreme Administrative Court of the Czech Republic from 2018, the owner had to make the hunting preserve open to the public although the area had been fenced. Therefore, the fine of CZK 800,000.00 (EUR 33,000.00) was imposed to the owner: he appealed to o higher court which upheld the fine in 2023. The fine has been in full paid.

Moreover, in 2023 the regular monitoring carried out again revealed damage to vegetation including successional forest growths. Therefore, the PLA Administration consequently commenced administrative offence procedures against the owner for breaking Act No. 114/1992 Gazette on Nature Conservation and Landscape Protection, as amended later, namely the prohibition to keep game in the Kútky Natural Reserve. With respect to free permanent accessibility of hunting preserves/game parks for the general public in the Czech Republic, amendment to Act 449/2001 Gazette on Hunting/Game Management, as amended later, has been submitted to the Parliament of the Czech Republic, being now debated there.

- 3. Special attention to reducing the proportion of the Norway spruce (*Picea abies*) and to increase the share of broad-leaved deciduous trees as nature-based solution related to climate change mitigation and adaptation, has been paid by the Bílé Karpaty/White Carpathians Mts. PLA Administration. The efforts to maintain natural and close-to-nature forest growths and to change others to be more natural and thus more resistant and resilient are financed both from the State Budget and the EU funds: through this way, the Bílé Karpaty /White Carpathians Mts. PLA Administration has been implementing the PLA Management Plan for 2022 2032 approved in June 2022, taking into account also the recommendations for the European Diploma holder. The management also uses the scenario analysis of changes in vegetation zones in the Czech Republic developed by the Mendel University in Brno. In 2024, the PLA Administration reviewed and approved 39 forest management plans for properties larger than 50 hectares.
- 4. In 2024, the PLA Administration issued 37 legal positions and submissions on landuse/territorial plan documentation, mainly those developed by municipalities within the Bílé Karpaty/White Carpathians Mts. PLA.

In 2024, the PLA Administration has continued the procedure to review the current PLA boundaries to include also some valuable habitats in the PLA's vicinity, to enhance the PLA's zonation and to more effectively protect and conserve the PLA's most valuable parts.

In the end of 2023, the Bílé Karpaty/White Carpathians Mts. Protected Landscape Area Visitor Centre – the Bílé Karpaty/White Carpathians Mts.' House of Nature (BK-WCHN) was approved in the historic quarter of the town of Veselí nad Moravou. An investor and an operator of the BK-WCHN is the Czech Union for Nature Conservation Bílé Karpaty/White Carpathians Mts. Local Chapter. The site was selected also due to good connection by public transport to the PLA's southern part as well as the fact that lively tourism on the Bat'a Canal and on adjacent bike trails provide plenty of visitors there. Design of the facility begun as early as in 2016. Finances were provided by the South Moravian Regional Office and the town of Veselí nad Moravou and small contributions were donated by some other municipalities. The original building at Veselí nad Moravou was completely restored. On the ground floor, there is a reception and exposition, while on the 1st and 2nd floor a lecture theatre, a library and offices for operating the BK-WCHN can be found. The other building is a passive new construction where a part of the exhibition is located on two floors. An atelier is available there not only for activities with children but also for various workshops and training courses. The whole BK-WCHN's exhibition puts on playfulness and creativity. Zoya Volkova's drawings on blueprint background are complemented by photos and movies as well as by a series of animations. All texts were translated into English and German. Adjacent winter outdoor space can also be used for various purposes, too. A water element - the Morava/Moravia River with meanders shows illustratively how water can be retained within the landscape and aims at children. The BK-WCHN was launched in March 2024 by Mr. Peter Hladík, Minister of the Environment of the Czech Republic and by Mr. Jan Grolich, South Moravian Region Governor/President.
