Background

The <u>Pool of International Experts on Safe Sport</u> (the "Pool") is a unique group of multidisciplinary experts covering all forms of violence and abuse against children in sport. The Pool provides opportunities for peer-learning, capacity building and opportunities for exchange of information and dialogue amongst those who have a role to play in combating and preventing violence and abuse in sport. The Pool brings together policy-makers, researchers and academics, specialists supporting people with lived experience, (child) safeguarding officers, trainers/consultants and agents of change.

The Pool of International Experts on Safe Sport was set up within the context of the European Union-Council of Europe joint project <u>"Child Safeguarding in Sport"</u> (CSiS). Since the end of the CSiS project in June 2022, the Secretariat support for the Pool has been provided by <u>"Start to Talk"</u>, a project of the <u>Council of Europe's Enlarged Partial Agreement on Sport (EPAS)</u> that aims to protect children against harassment and abuse in sport.

In accordance with the mandate of the Pool of International Experts on Safe Sport, its members meet once a year to address topical challenges, share their experiences, network, discuss their annual work programme, and provide an insight into EPAS' activities. The 2022 annual meeting included a roundtable on "Children's participation in policymaking". High-level experts on child participation had an exchange of views and know-how with the Pool members on the benefits and risks of children's participation in the development of child safeguarding policies in sport, as well as the reasons why sport is often a challenging environment for children to have their voices heard and how they can have an impact in decision making. The success of last year's edition has encouraged the Secretariat to propose the same format for 2023, with an *in camera* Pool meeting in the morning and a roundtable in the afternoon of 5 December. The members of the EPAS Governing Board and Consultative Committee, the "Start to Talk" focal points, as well as representatives from sport organisations members of the EPAS Consultative Committee will be invited to participate in the afternoon session of the annual meeting of the Pool.

Objectives of the meeting

The objectives of the morning in camera meeting:

- Exchange information on activities relating to safe sport by providing updates on:
 - the activities of the Pool members;
 - o the activities of the Council of Europe in the field of safe sport;
- Working on the 2023 deliverables, specifically through a group discussion;
- Discussing relevant points pertaining to the procedure and running of the Pool.

The objectives of the **afternoon roundtable**, which will be attended by a broader audience, is to create an opportunity for an exchange of opinions and know-how between professionals from different sectors, to address emerging human rights challenges in the national and international sharing of criminal and disciplinary backgrounds of employees and volunteers in regular contact with children in sport. Following the presentations, the members of the Pool of experts and other participants will be invited to share their views as to how to enable human rights-compliant information sharing, and to explore avenues for further action.
