Mapping Study



The state parties of the **Convention on the Rights of the Child** have agreed as follows:

Article 28 – right to education

Article 30 – right to enjoy their own culture and language

Article 31 – right to rest and leisure

Article 32 – protection from economic exploitation

Article 33 – protection from drugs

Article 34 – protection from sexual exploitation

Article 19 – protection from all forms of physical or mental violence, injury, neglect, maltreatment or exploitation

Article 38 – care for children affected by armed conflict

Article 2 – rights should be ensured without discrimination

Timeline: May – June 2024

6 500 000 Ukrainians fled their country¹

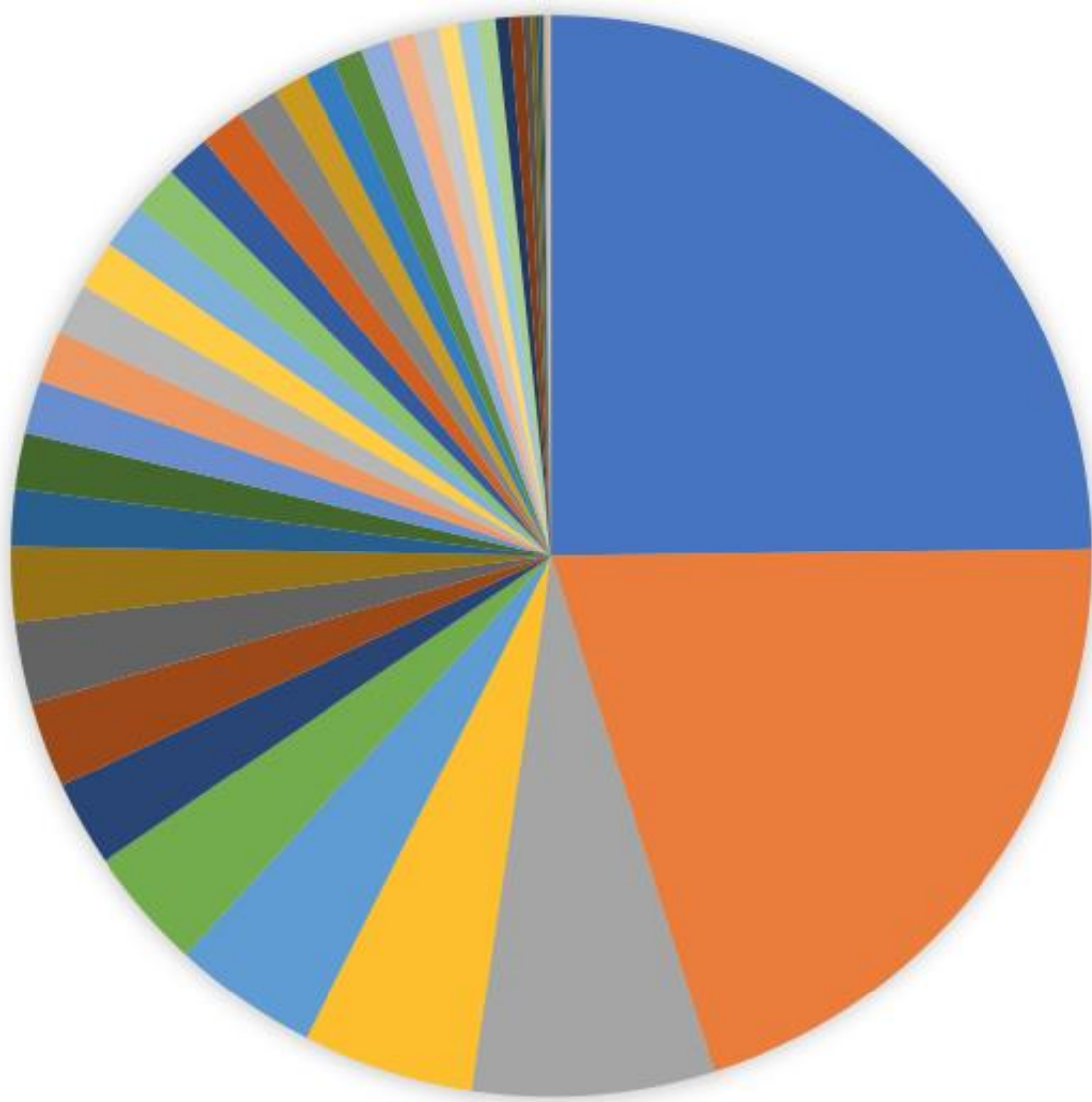
40% of refugees are children and young people²

Refugees from Ukraine recorded in the country as of May 2024

- Germany (25%)
- Poland (20%)
- Czechia (7%)
- UK (5%)
- Italy (4%)
- Spain (4%)
- Moldova (3%)
- Slovakia (3%)

Czechia (32,9), Lithuania (27,7) and Poland (25,9)

– highest ratio





Approach to schooling

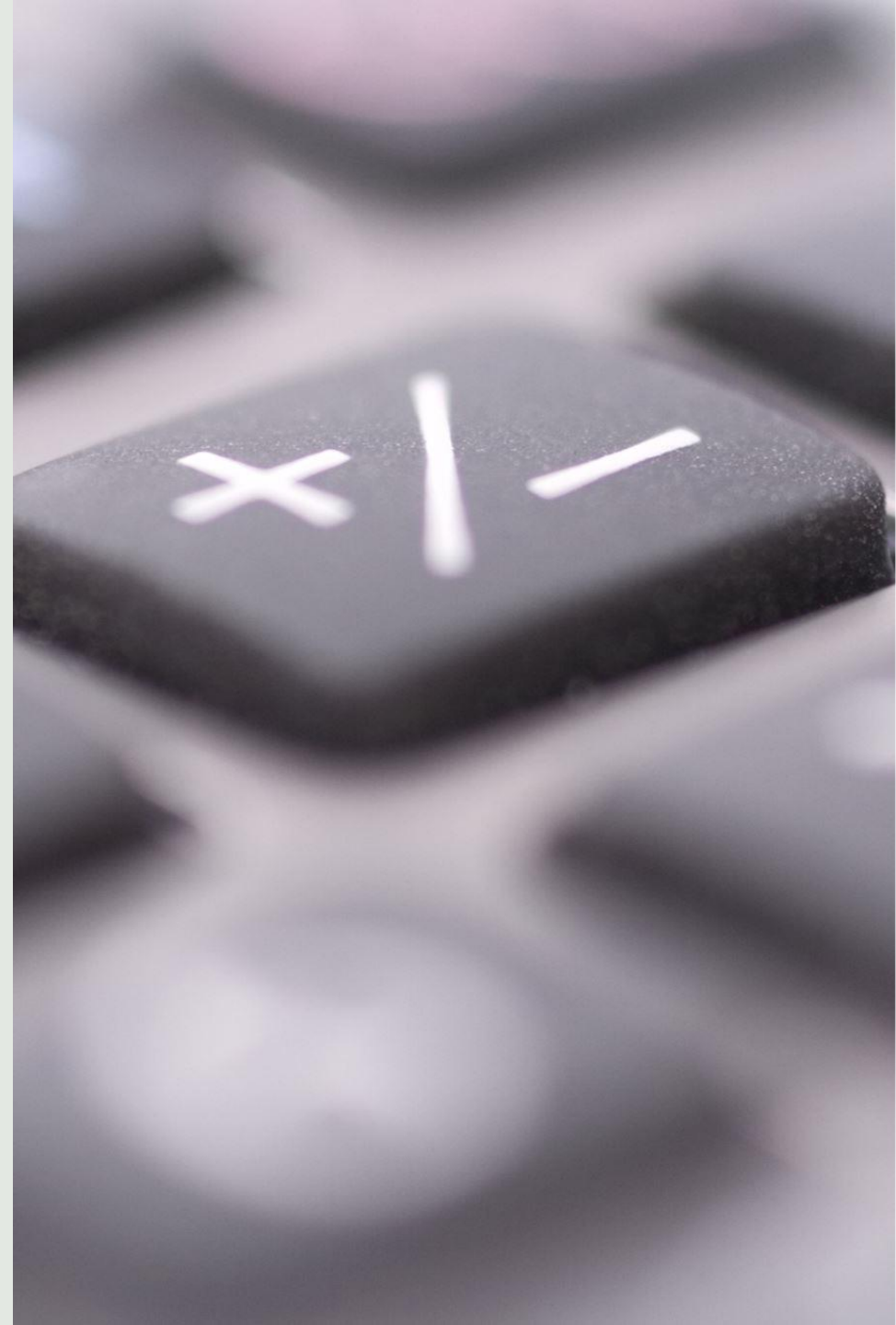
- Compulsory

Enrolment to schools



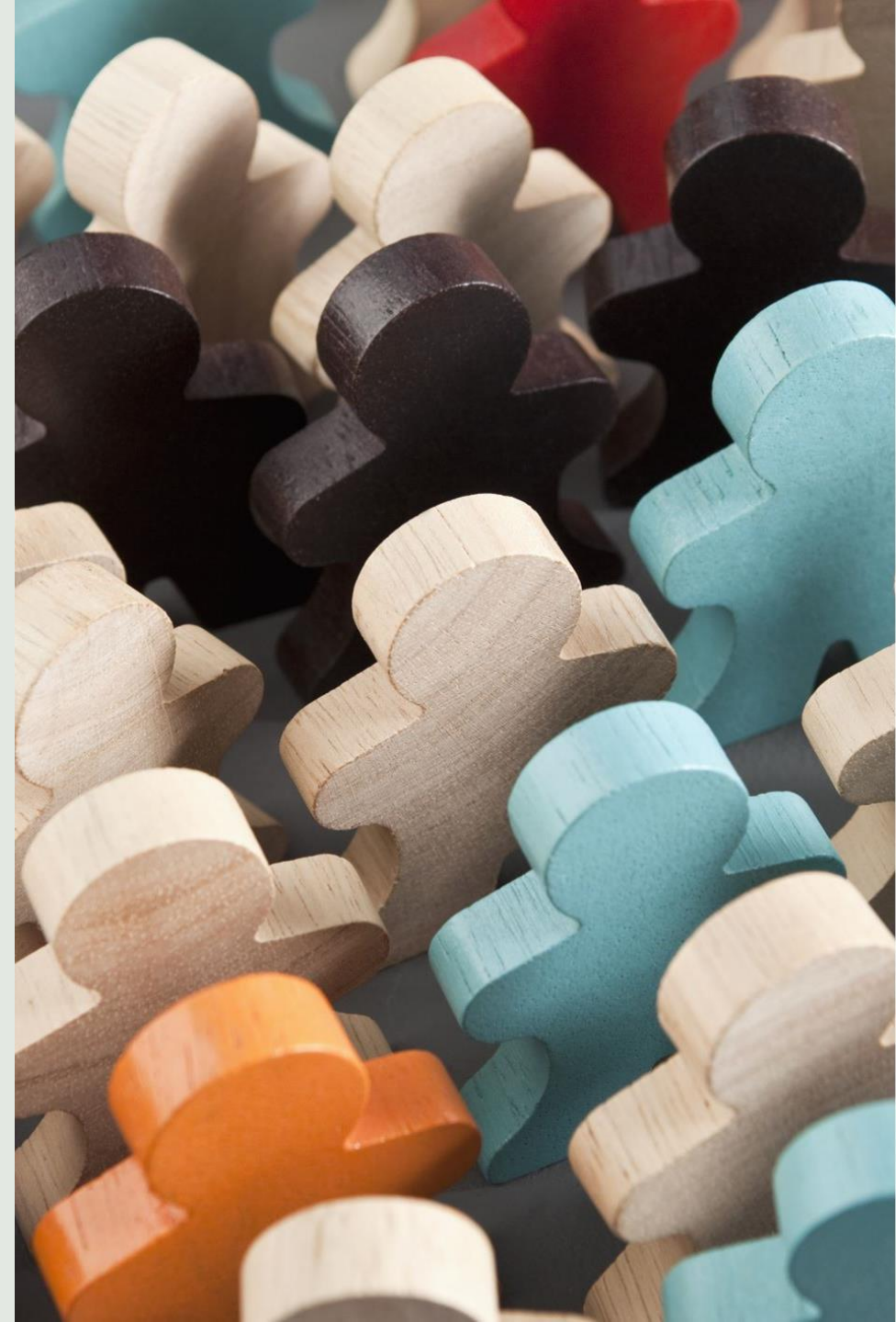
- Simplified enrolment

 - Coordinated enrolment

- **Coordinated enrolment**

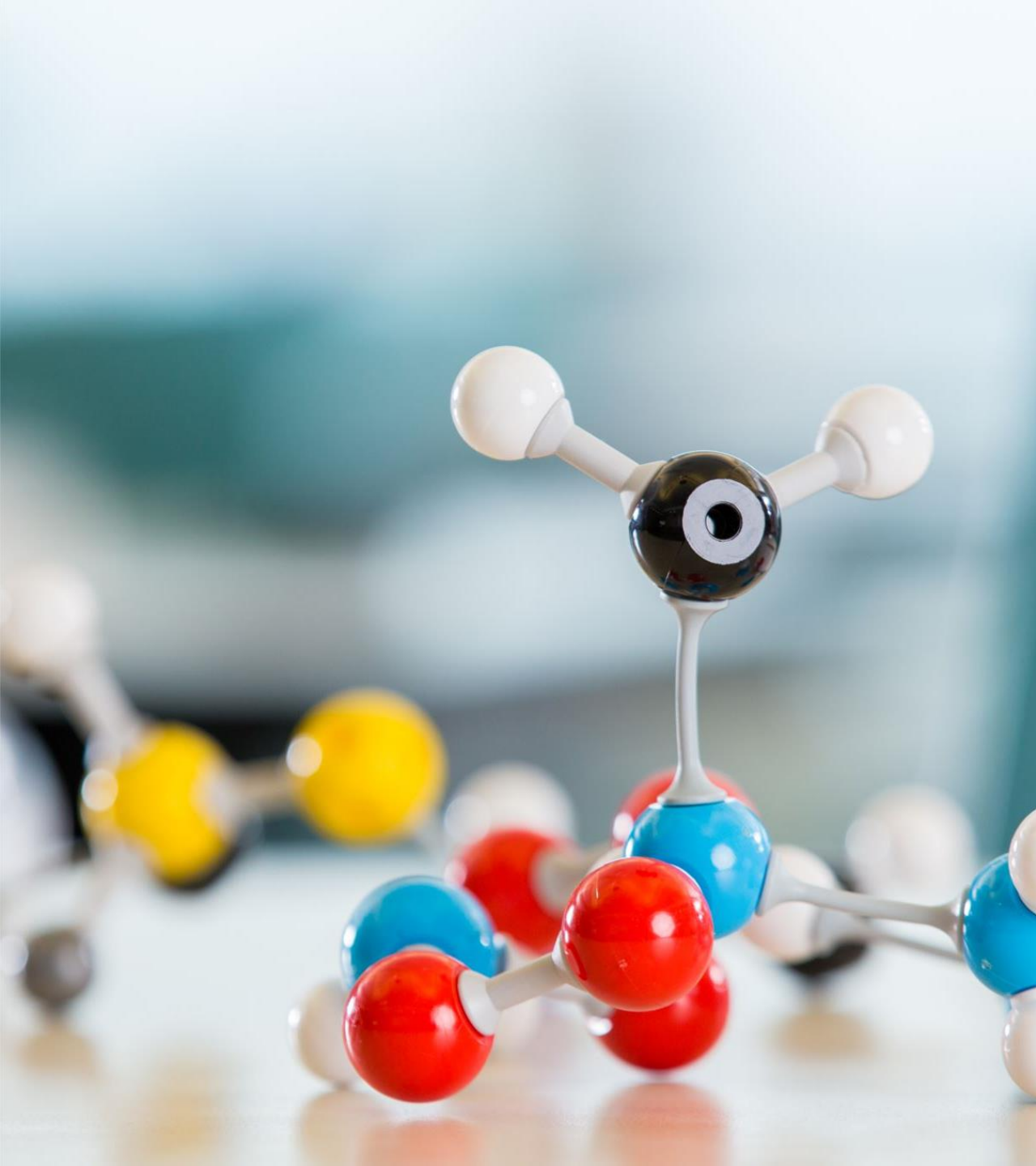


Initial placement



- Based on age
- Based on the number of years of documented education
- Based on interviews with a learner
- Based on interviews with parents/ guardians
- Based on tests
- Based on mutual decisions
- **Best interest of a child**

Means of integration



- Language courses, Remedial classes
- Recruitment of Ukrainian-speaking staff, staff with migrant experience, intercultural assistants
- Individual programmes
- Close cooperation with parents
- Peer learning and collaborative forms of work
- Joint extracurricular activities

- Ukrainian language classes as a second foreign language
- Ukrainian community schools

- Libraries and non-profit organisations offer free digital books in Ukrainian language
