

## TENDER FILE / TERMS OF REFERENCE (Competitive bidding procedure / One-off contract)



### Purchase of computer hardware Contract N° 8665/2020/01/10

The Council of Europe Project "Human Rights Compliant Criminal Justice System in Ukraine" (the Project) is implemented from July 2019 to December 2020, with the possibility of potential prolongation. One of the project outcomes is facilitating institutional and operational effectiveness and professionalism of the Public Prosecution System in Ukraine.

In that context, the Project is looking for a Provider for the provision of IT hardware for the newly created department on the supervision of torture/ill-treatment related cases attributable to law enforcement officers of the Office of the Prosecutor General of Ukraine (See Section A of the Act of Engagement).

#### A. TENDER RULES

This tender procedure is a competitive bidding procedure. **In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe<sup>1</sup>, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.**

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. Each lot will be awarded to the Provider providing the best value for money for the lot concerned, on the basis of the award criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be a legal person or private entrepreneur, except consortia.

Tenders shall be submitted **by email only** (with attachments) **to the email address indicated in the table below, with the following reference in subject: "Purchase of computer hardware 8665/2020/01/10"**. Tenders addressed to another email address **will be rejected**.

The general information and contact details for this procedure are indicated on this page. You are invited to use the CoE Contact details indicated below for any question you may have. **All questions shall be submitted at least 5 (five) working days before the deadline for submission of the tenders and shall be exclusively addressed to the email address indicated below with the following reference in subject: "8665/2020/01/10 Qs"**.

## B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached). Please note that each lot concerns a different series of deliverables. Tenderers may tender for one, all or several lots.

## C. FEES

All tenderers are invited to fill in the table of fees as reproduced in Section A of the Act of Engagement.

Fees should be indicated in UAH in two columns: without VAT in one column and including VAT indicated separately in the second column.

## D. ASSESSMENT

### *Exclusion criteria and absence of conflict of interests*

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations)<sup>2</sup>

Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are or are likely to be in a situation of conflict of interests.

### *Eligibility criteria*

- Being a registered legal entity or a private entrepreneur in accordance with applicable Ukrainian legislation and being specialised in the field of technical equipment procurement (IT, office equipment or similar);
- 2 (two) years of experience in providing similar services;

### *Award criteria*

**For lot 1** Computers and Laptops; **Lot 2** - Video and Photo Equipment; **Lot 3** - Computer peripherals and **Lot 4** – Portable printing devices:

- Financial offer (60%);
- Quality of the offer (40%), including technical characteristic and compliance with minimum technical specification requirements (as indicated in Section A of the Act of Engagement), timeframe for delivery, warranty period etc.

Multiple tendering is not authorised.

## E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

## F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- **A completed and signed copy of the Act of Engagement<sup>3</sup> (See attached)**
- Tenderer's registration documents;
- Brief description proving that provider has relevant experience in the field of providing similar services (at least for 2 years);

<sup>2</sup> The Council of Europe reserves the right to ask tenderers, at a later stage, to supply an extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three above listed exclusion criteria are met, and a certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met.

<sup>3</sup> The Act of Engagement must be completed, signed and scanned in its entirety (i.e. including all the pages). The scanned Act of Engagement may be sent page by page (attached to a single email) or as a compiled document, although a compiled document would be preferred. For all scanned documents, .pdf files are preferred.

- Title of the proposed IT equipment and link to the product (including information of warranty period);
- Technical specification of the proposed IT equipment (in the part that is not covered by the minimum technical specification requirements or supersede them, if any);
- Timeframe of the provision of expected deliverables;

**All documents shall be submitted in English (with only exception to registration document which can be submitted in Ukrainian with brief summary translation into English – name of the company, date of registration, types of economic activities which can be legally provided), failure to do so will result in the exclusion of the tender.**

**If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.**

**The Council reserves the right to reject a tender if the scanned documents are of such a quality that the documents cannot be read once printed.**
