Presentation by Francesco Crisafulli, Vice-President of the European Committee on Legal Cooperation (CDCJ),

This non-binding guide has been developed by the CDCJ for professionals working in the field of migration as a practical tool to help improve their ability to prevent any risk and form of abuse or violation of the rights of persons deprived of their liberty, and to strengthen respect for their dignity and fundamental rights, in accordance with existing international and European standards. The presentation of this guide will be followed by **an exchange of views**.

- New material from the European Human Rights Training Programme for Legal Professionals (HELP) (online courses on LGBTI Persons in Asylum Procedures and Transition to Adulthood)

Presentation by Giulia Lo Presti, HELP Programme.

Both modules were published on the HELP platform in July 2023. The <u>first one</u> offers a better understanding of the rights of LGBTI asylum-seekers in different stages of their asylum-claim, covering both the substantive and procedural aspects. <u>The second module</u> focuses on presenting the existing standards and guidelines designed to ensure that young refugees and migrants can enjoy their fundamental rights after the age of 18, both in law and in practice.

5. Update on the issue of migrant smuggling

Presentation by Mr Clément Bailly, European Committee on Crime Problems (CDPC).

This topical issue comes after the declaration of the Heads of State and Government meeting in Reykjavík on 16 and 17 May 2023. The declaration calls on the Council of Europe and its Member States to intensify efforts to foster and improve international co-operation on the smuggling of migrants and trafficking in human beings, while continuing to protect victims and respect the human rights of migrants and refugees.

The discussion on this topic offers an opportunity to explore possible areas of intervention by the Council of Europe, particularly in the light of the information meeting that was organized on 13 October 2023 focusing on the fight against migrant smuggling at the European level.

The Focal Points on Migration will be asked to exchange views on the following questions:

- What are the current challenges in the fight against migrant smuggling (legal framework, state of international cooperation, prevention, investigation, prosecution, and protection of victims)?
- What role should the Council of Europe play in this area?

This recommendation includes a dedicated chapter addressing asylum claims by LGBTI persons.

Mr Galles will present the complex situation of the 200,000 to 500,000 Belarusians who have fled to other Council of Europe countries, their access to protection and rights in these countries. He will also share the recommendations of the Parliamentary Assembly of the Council of Europe.
