9th Meeting of the Statutory Committee Strasbourg, 12 October 2012 15h00-17h00 Room of the Committee of Ministers, Strasbourg

Final Decisions

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS), composed of the representatives on the Committee of Ministers of the member states of the Agreement¹, chaired by Ambassador Alexander Alekseev, Permanent Representative of the Russian Federation, held its 9th meeting in Strasbourg on 12 October 2012. The list of participants is featured in **Appendix I** of this document.

The Statutory Committee:

- I. Adopted the agenda as it appears in the **Appendix II** to this document;
- II. Approved the 2011 annual accounts of the Enlarged Partial Agreement for the period running until 31 December 2011 and consequently adopted Resolution EPAS-Res(2012)1 in relation to the financial statements of the Enlarged Partial Agreement on Sport (EPAS) for the financial year ending 31 December 2011, as it appears in **Appendix III** to this document;
- III. Noted the verbal report presented by the Secretariat concerning membership and observer requests by new countries, international sports federations and sports NGOs to the EPAS;
- IV. Noted the verbal report presented by Mrs Ewa Markowicz, Chair of the Governing Board, concerning the present priorities and future projects of the EPAS;
- V. Determined the total of members' compulsory contributions to the EPAS for 2013; approved the budget for the period to 31 December 2013 for this Enlarged Partial Agreement, and consequently adopted Resolution EPAS-Res(2012)2 as it appears in **Appendix IV** to this document;

- VI. Took note of the invitation from the Swiss Authorities to host the 13th Council of Europe Conference of Ministers responsible for sport in Macolin, on 17-19 September 2014, and consequently invited the Secretariat to include this event in the Calendar of Ministerial Conferences in the section "Conferences organised by Partial Agreements", according to the EPAS Statute and to Resolution CM/Rec(2011) 7.
- VII. Agreed that the date of the next meeting of the Statutory Committee will take place in October 2013, the exact date being confirmed in due course by the Secretariat.
- VIII. Approved the invitation of Austria and Turkey to take part in the negotiation of the possible convention on the manipulation of sports results and agreed to transmit the proposal to the Ministers' Deputies in its composition restricted to the representatives of the members of EPAS, for invitation without further debate.

Resolution EPAS(2012)1

concerning the budgetary management accounts of the Enlarged Partial Agreement on Sport (EPAS) for the year ended 31 December 2011

(Adopted by the Statutory Committee on 12 October 2012 at its 9th meeting)

The Statutory Committee under the terms of Article 5.4 of the Statute of the Enlarged Partial Agreement and in its composition restricted to the Representatives of the States members in 2011 of the Enlarged Partial Agreement on Sport.¹

Having regard to Resolution CM/Res(2007)8 establishing the Enlarged Partial Agreement on Sport;

Having regard to Article 68 of the Financial Regulations;

Having regard to the budgetary management accounts of the Enlarged Partial Agreement on Sport for the year ended 31 December 2011, as presented by the Secretary General;

Having regard to the opinion of the External Auditor;

Having regard to the report of the External Auditor,

Resolves as follows:

- 1. The financial statements of the Enlarged Partial Agreement on Sport for the year ended 31 December 2011 are approved (CM(2012)100 add, pages 113-120);
- 2. The unexpended appropriations for the financial year 2011 amounting to €21 960.70 as shown in the budgetary management accounts (CM(2012)100 add, page 120) presented by the Secretary General, are cancelled:
- 3. Approval is hereby given to the apportionment among the member States of the €21 960.70 surplus; according to the scale of contributions adopted for the financial year 2011.
- 4. The share of the surplus of the Enlarged Partial Agreement on Sport budget due to each state will be applied to meet any additional contributions for which states may become liable should supplementary appropriations be granted in the 2012 budget, any part of the share that remains being considered as an advance on its contributions for 2013.
- 5. The budgetary management accounts with the present resolution, as well as the report of the External Auditor, will be transmitted to the Committee of Ministers.

Resolution EPAS-Res(2012)2 concerning the Enlarged Partial Agreement Sport 2013 Budget

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS)¹, composed of the representatives on the Committee of Ministers of the member states of the agreement.

Having regard to Resolution CM/Res(2007)8 of 11 May 2007 authorising the establishment of the Enlarged Partial Agreement on Sport;

Having regard to Articles 19, 21 et 28 of the Financial Regulations;

Having noted the changes in the EPAS membership for 2013, compared to 2012;

Having regard to the Programme and Budget for 2012-2013 (CM(2011)130 addendum);

Resolves as follows:

1. The budget of expenditure and the budget of receipts for 2013, totalling €756 000 according to Table A appended hereto are hereby approved.

- 2. Approval is hereby given to the apportionment, among the states which are members of the Enlarged Partial Agreement on Sport of the contributions for 2013 totalling €756 000 according to Table B appended hereto.
- 3. The total of the budget of receipts shall be a function of actual receipts. The budget of expenditure and receipts will be adjusted accordingly in the course of the financial year.
