On 12-13 February 2014, the Ministers' Deputies communicated to the CAHDI Recommendation 2037 (2014) of the Parliamentary Assembly of the Council of Europe – "Accountability of international organisations for human rights violations" for information and possible comments by 18 April 2014. A draft opinion was circulated by email on 6 March 2014 (document CAHDI (2014) 8 prov), inviting the CAHDI members to submit their comments on this document before 17 March 2014. These comments are reproduced in document CAHDI (2014) 8 Addendum. Delegations are invited to re-examine document CAHDI (2014) 8 prov in light of the comments received with a view to adopt the opinion of the CAHDI on Recommendation 2037 (2014) which will be transmitted to the Ministers' Deputies.

Immunity of State Owned Cultural Property on Loan

At the 46th meeting of the CAHDI, delegations held an exchange of views on the issue of "Immunity of State Owned Cultural Property on Loan" on the basis of document CAHDI (2013) 10 which was prepared following the announcement made at the 45th meeting of the CAHDI regarding an initiative of the Czech Republic, supported by Austria and the Netherlands. Following the instructions of the Committee at the 46th meeting, the Secretariat and the Chair have drawn up a questionnaire aimed at providing an overview of specific national legislations in this field (document CAHDI (2014) 2). Delegations are invited to examine this questionnaire and to provide any relevant information concerning this issue. The replies to this questionnaire will be examined at the 48th meeting of the CAHDI.

Immunities of special missions

At the 46th meeting, the delegation of the United Kingdom submitted a document (document CAHDI (2013) 15) proposing that the CAHDI initiates a discussion on the law relating to special missions immunity status. Following the instructions of the Committee, a questionnaire has been drawn up on this issue aiming at establishing an overview of legislations and specific national practices in this field (document CAHDI (2014) 3). Delegations are invited to examine this questionnaire and to provide any relevant information concerning this issue. The replies to this questionnaire will be examined at the 48th meeting of the CAHDI.

Database on "State practice regarding State Immunities"

Delegations are informed that since the 46th meeting of the CAHDI, Portugal has submitted a contribution to the database on the issue of seizure of bank accounts.
