The Council of Europe is the continent's leading human rights organisation. It comprises 47 member states, 28 of which are members of the European Union. All Council of Europe member states have signed up to the European Convention on Human Rights, a treaty designed to protect human rights, democracy and the rule of law. The European Court of Human Rights oversees the implementation of the Convention in the member states.

On 16 April 2014, the 47 member states of the Council of Europe adopted a Guide to Human Rights for Internet Users. The guide should serve as a reference for all the stakeholders interested in promoting and guaranteeing the full enjoyment of human rights online.
