Aim of the Pilot Initiative

Praparation phase:

- Raising awareness of the Charter in each country through the preparation
- Finding the **hidden and unconcious** implementation examples

Visit phase:

- Looking, listening, understanding through the eye of the other
- Supporting the implementation of the Charter through questions
- Discussing current challenges and possible solutions





Approach of the Pilot Initiative

- Basis:
 - Very different context in the partner countries
 - Allready existing intensive work on EDC/HRE in different areas (organisations, programmes of organisations, schools etc.)
- Look at some specific »good practice examples« in EDC/HRE in each country, selected by the hosting country itself
- Discuss the observed elements together by visiting good practice examples
- Reflect the observed elements by consulting the Charter
- Bottom up approach based on individual learning processes and learning through cooperative exchange





Process of the Pilot Initiative

Ways of Implementation of Democratic Values and Human Rights Law in Ukraine Main Directions

- Dissemination of democratic civic education ideas;
- Introduction of civic school courses (We Are the Citizens, Human Rights, Law, etc.);
- Integration of some elements of the civic education into the curriculum of school subjects (such as *History, Literature, Economics and others*);
- extra-curriculum and extra-school activities;
- Democratization of the school life introduction of school or students' self-governing systems;
- Training of teachers;
- Printing of information leaflets and manuals.

- Responsibility for everything that happens in their schools and community;

Product: A Visit Booklet: ,DEMOCRACY IN PRACTICE'

Publication including the following elements:

- (1) History and selected approach of the Pilot Initiative
- (2) Project documentation by the host
- (3) Report / impression by each member of the visiting delegation
- (4) Reflection on the Pilot Initiative (strenghts, opportunities, possible threats, recommendations based on the experience)

All elements will **reflect** different aspects of the Charter and therefore support the implementation by **individual exchange and learning processes**





Experiences from the Pilot Initiative

- »Good practice« instead of »best practice«
- Discussing also »hidden elements« of EDC/HRE
- Network of people and/or organisations that agree on what they will show
- Variety of implementation possibilities (organisations, programmes in formal and non formal education, school lessons, research projects etc.)
- Reading the Charter and defining itself in which part it fullfills some point of the Charter without even knowing it (Reflection-on-the-Charterapproach)
- Not trying to cover all parts of EDC/HRE, but to select some elements, knowing that it is impossible to be complete
