



APPROACH AND WORKING METHODS

The Council of Europe is the oldest European organisation. With 47 member countries, it touches the lives of over 800 million people. Its core mission is the promotion of human rights, democracy and the rule of law. Education is integral to this mission. In 1997 the Council of Europe embarked upon a radically new programme, with the ambitious goal of providing every person in Europe with an opportunity for education for democratic citizenship and human rights. Today, the Council of Europe's Learning and Living Democracy programme is widely recognised as one of the leaders in the field, both in Europe and elsewhere.

Why education for democratic citizenship and human rights?

The Council of Europe programme reflects a growing world-wide consensus that education has a key role to play in the development of sustainable forms of democracy and respect for human rights in society. Education is also a major contributor to community cohesion and social justice, and one of society's strongest bulwarks against the forces of violence, racism, extremism, xenophobia, discrimination and intolerance.

How does it benefit individuals?

Education for democratic citizenship and human rights empowers people to make a difference in their communities and nations. It turns people who feel remote from the world of politics and politicians into engaged citizens, ready to defend their human rights and the human rights of others. It develops values, confidence and a sense of responsibility, as well as practical knowledge and skills.

How is it learned?

Learning for democratic citizenship and human rights doesn't just take place in schools in civic or citizenship education lessons. It is a lifelong process based on experience and practice as well as formal teaching, in which a wide range of actors have a part to play, and to which all types and phases of education have something to contribute – formal, non-formal and informal. There is a role for youth organisations and NGOs as well as national ministries and local authorities, for higher education institutions as well as schools and kindergartens, and for parents and children as well as teachers and school leaders.

What is distinctive about the Council of Europe programme?

The Council of Europe programme offers a uniquely structured approach to citizenship and human rights learning,

sensitive to the complex nature of the educational challenge and variations in educational practice in different member states. Central to the programme has been the identification of the social arenas, locally and nationally, with most potential to contribute to educational development – e.g., policy making, school leadership, teacher education and classroom teaching – on which to base its main activities. Integral to this has been the production and dissemination of a series of publications, practical tools and support documents, targeted at specific audiences – e.g., high level policy-makers, school leaders, teacher educators and teachers.


Network of Coordinators

The Democratic Citizenship and Human Rights programme and its publications draw on the best expertise and practice currently available in the 47 Council of Europe member states. It is assisted by a network of representatives appointed by the member states, all leaders in the field in their own country. They are called Education for Democratic Citizenship and Human Rights Education (EDC/HRE) Coordinators, and their main function is to foster development of citizenship and human rights education in their country and to liaise between national activities and the Council of Europe programme. Seminars, conferences and forums enable regular exchanges of good practice and the piloting and dissemination of new materials on an international basis, guaranteeing the European credentials of the programme and its potential for application in the wider world.

Without the authority that comes with political recognition, educational initiatives are unlikely to be taken sufficiently seriously to make a difference. 



Developing a culture of democracy and human rights in education is a key factor in improving performance. Yet while quality assurance principles have been widely applied in education, the concepts of citizenship and human rights education are rarely integrated in this process. This publication, Tool for Quality Assurance of Education for Democratic Citizenship in Schools, provides decision-makers, administrators, inspectors and school leaders with a framework that can be applied equally across an education system as well as to educational institutions individually.

Education for democratic citizenship and human rights is too broad and too important to be left to the state alone. 

Democratic and human rights values and practices are learned not only through formal teaching, but also through the experience of living and working in a community that respects them. Yet educational institutions are often unaware of the benefits of becoming more participatory communities.
