TO THE COUNCIL OF EUROPE CONVENTION ON THE PROTECTION OF CHILDREN AGAINST SEXUAL EXPLOITATION AND SEXUAL ABUSE

(T-ES)

REPORT OF THE 1st MEETING

Strasbourg 20-21 September 2011

Item 1: Opening of the meeting

1. The first meeting of the Committee of the Parties to the Council of Europe Convention on the protection of children against sexual exploitation and sexual abuse (hereafter referred to as the Committee) was opened by Mr Jan Kleissen, Director of Standard Setting, Directorate General of Human Rights and Legal Affairs. He informed the participants about the reform of the Council of Europe which will lead to organisational changes in the secretariat as of 1 October 2011. As a consequence, the future secretariat of the Committee will be the Children's Rights Division.

Item 2: Speech by Ms Maud de Boer-Buquicchio, Deputy Secretary General of the Council of Europe

2. Ms Maud de Boer-Buquicchio, Deputy Secretary General of the Council of Europe addressed the Committee in an opening speech, welcoming the participants. In her opening remarks she referred to the important role that the Committee should play in removing obstacles to the implementation of the Convention on the protection of children against sexual exploitation and sexual abuse (hereafter referred to as the Convention) and in advising on the best ways to translate its provisions into effective laws and policy measures. She informed that the Convention has been ratified so far by 14 member states and that a number of new ratifications were expected in the coming months. Furthermore, she mentioned that the Convention was signed by another 28 member states and she urged all states which had not already done so to ratify the Convention. To support the ratification process, she also mentioned the launch of the ONE in FIVE Campaign in 2010 to raise awareness about sexual violence against children and to promote the Convention, and she paid tribute in particular to the key role that the Council of Europe's Parliamentary Assembly had played through the network of contact parliamentarians, who have strongly promoted ratification and implementation of the Convention. She continued by highlighting the main role of the Committee, which will be to collect, analyse and exchange experiences and good practices between Parties. Sharing experiences she believed would allow national authorities to benefit from a wide range of expertise, knowledge and practices and would foster harmonisation of policies among the Parties and develop synergies for finding practical solutions to common problems. She continued by pointing out that the role of the Committee should also be to identify possible problems and a number of sensitive issues which must be addressed during this process. To illustrate this she gave the example of an association based in the Netherlands which promotes paedophilia on the Internet; in this context she raised the issue of what can be done by national authorities in order to tackle such situations within the framework of the Convention. She concluded her speech by explaining that the secretariat of the Committee would in future be ensured by the Children's Rights Division, Directorate General I/Human Right and Rule of Law. Finally, she expressed her gratitude to Mr Eric Ruelle, who previously guided the drafting process of the Convention successfully to an end.

Item 3: Election of the Chair

3. The Committee unanimously elected Mr Eric Ruelle (France) as Chair of the Committee.

Item 4: Adoption of the Agenda

4. The Committee adopted the agenda as it appears in Appendix I.

Item 5: Presentation of the ONE in FIVE Campaign

- 5. Ms Regína Jensdóttir, Head of the Children's Rights Policies Division and Manager of the Programme "Building a Europe for and with children", presented the Council of Europe's ONE in FIVE Campaign to encourage the signature and ratification of the Convention and to launch comprehensive awareness-raising actions to prevent and combat sexual exploitation and sexual abuse of children; trafficking in children; cybercrime targeting children. She explained that available data suggest that about 1 in 5 children in Europe are victims of some form of sexual violence, hence the name of the campaign. Furthermore, she continued by clarifying that child sexual violence can take many forms: sexual abuse within the family, child pornography and prostitution, corruption, solicitation via Internet and sexual assault by peers. Moreover, she also mentioned that the campaign has a strong parliamentary dimension through the partnership and support of the Parliamentary Assembly of the Council of Europe which has set up a network of parliamentarians and which have a key role to play in the law reforms at national level. She concluded by informing the participants that around 6 states have so far launched national campaigns, including Mexico, and that another 6-7 states are planning to launch national campaigns shortly as well.
- 6. Ms Marlene Rupprecht, Member of the Social, Health and Family Affairs Committee of the Parliamentary Assembly of the Council of Europe (PACE), made introductory comments on the parliamentary dimension of the campaign, which aimes to promote the Convention. She emphasised the importance of developing the existing network of parliamentarians and suggested its extension to international organisations such as the European Union.

Item 6: Information by the Secretariat

7. Mr Carlo Chiaromonte, Head of the Criminal Law Division and Executive Secretary of the first meeting of the Committee, provided the Committee with practical information on the meeting. He reiterated the participants that following organisational reforms within the Council of Europe, Ms Regína Jensdóttir, Head of Children's Rights Policies Division and Manager of the Programme "Building a Europe for and with children", will be in charge of the Secretariat of the Committee as of the holding of the next meeting. Mr Chiaromonte then introduced the draft Rules of Procedure (doc. T-ES (2011) 04) prepared by the Criminal Law Division and stressed that its sole purpose was to facilitate the first discussions of the Committee. He specified that the draft Rules were inspired in large part from the Rules of Procedure of other monitoring committees, as well as from Resolution Res(2005)47 of the Committee of Ministers on committees and subordinate bodies, their terms of reference and working methods.

Item 7: Adoption of the Rules of Procedure of the Committee

8. The Committee proceeded with the first reading of the draft Rules of Procedure and went through Section I ("Organisation of the Committee"), Section II ("Conduct of business"), Section II ("Evaluation process") and Section IV ("Final Clauses"). After a round of general remarks on the draft Rules of Procedure (hereafter abbreviated RoP) the following suggestions for redrafting and amendments were made:

9. General remarks:

- a) The main objectives of the Convention are, firstly, to evaluate and monitor contracting Parties and, secondly, to raise awareness on sexual violence against children and, thirdly, to exchange information and good practices in the Council of Europe (hereafter refered to as CoE) member states. Therefore, a separate chapter should be added to the RoP for awareness-raising and information-sharing (equivalent to Section III for the evaluation/monitoring);
- b) given the early stages of the Convention, it should be stated in the RoP that the Committee also has the role to support the signature and ratification of the Convention;
- c) make sure to give reference to international overarching instruments, such as the UNCRC.

10. Section I: Organisation of the Committee

- a) As reference the mentioning of specific CoE Committees, such as the European Committee on Crime Problems (CDPC), it was suggested to find a more all-encompassing wording in the RoP to ensure that the Committee has the possibility of including the opinions of a large variety of (CoE) bodies relevant to the Convention (Rule 1.3.c);
- b) regarding the annual reports it was proposed that the annual reports are thematically defined/renamed and further specified (Rule 1.3.f);
- c) the composition of the Committee must be further completed with all relevant bodies/representatives to the Committee and should be categorised (State Parties with the right to vote, member states that have no vote, observes) to get a better overview (Rule 2.2);
- d) when redrafting this section it will also be important to keep in mind the new Resolution on the functioning of CoE committees which will be adopted by the Committee of Ministers in the near future and will enter into force as of 1 January 2012;
- e) introduce a gender perspective and geographical balance in the description of the election of the chair and vice-chair and clarify the time period of the mandate of the chair, vice-chair and the bureau in the second draft RoP (Rule 3.1);
- f) change the wording of the possibility of appointing ("may appoint") a Bureau to mandatory ("shall"), (Rule 4.1);
- g) add that the Bureau will also be responsible for the preparation and approval of the agenda (Rule 4.2) and that a gender perspective should be applied to the composition (Rule 4.3).

11. Section II: Conduct of business

- a) Amend rule 6 to reflect that on ad-hoc basis the Committee may convene its meetings outside Strasbourg in accordance with CoE Rules (Rule 6);
- b) include the competencies of the Bureau for the preparation of the agenda (Rule 9.1 and 9.3);
- c) extend the timeframe for receiving the working documents to four weeks (Rule 10.2);
- d) introduce (change the existing text) that the Chair may agree to examining documents arriving after the deadline for the Committee meetings (Rule 10.3);

- e) to accompany the list of decisions with a short summary report containing the main issues raised, all of which can be approved through written procedure or at the next meeting of the Committee (Rule 10.5);
- f) consider how public and accessible the Committee's documents should be in general (Rule 10.5) and the need to make a clear distinction between working documents and decisions of the Committee (Rule 10.4):
- g) the need to specify the quorum in Rule 11 was raised and both simple majority and 2/3 majority were suggested. The majority of the Committee was in favour of a 2/3 majority;
- h) extend the right of initiative to organising hearings to the Bureau. Another aspect to reflect upon is how many annual hearings are foreseen;
- i) explicitly clarify the abstention vote in the RoP;
- j) compare Rule 20 and 26 and see if one of them is not redundant.

12. Section III: Evaluation process

- a) the roles and the appointment of the independent experts were discussed in particular, and the need to find a balance between the evaluation process, monitoring and the collection and analysis of data of good practices (Rule 21);
- b) add a gender balance to the nomination of experts and include clear criteria for the procedure of selecting/appointing experts (Rule 21.1.b);
- c) the need to integrate and take into account experts of new member states who will ratify the Convention after the RoP have been adopted and after the first expert group has been appointed;
- d) the suggestion was made to have an overlapping system of experts with a variety of time in terms of appointments; take stock of other RoP for CoE Convention experts (Rule 21.1.d);
- e) the role of the experts must be clearly defined in relation to the Committee so parallel work and/or overlaps are avoided, the frequency of expert meetings must also be determined (Rule 21.2);
- f) with regard to the question of how the evaluation process should be carried out, three possible approaches were mentioned (article by article; chapter by chapter; or a thematic approach). The majority of the Committee was in favour of the thematic approach and instructed the Secretariat to propose a list of themes for its next meeting (Rule 22-25);
- g) the Committees' opinion must be taken into account prior to the finalisation of the expert report;
- h) tackle the issue of satisfactory level of respective member state's replies to questionnaires/expert work and when alternative information/NGO contributions are sought;
- i) add NGO alternative reports as one of the sources of information in Rule 22;
- i) rule 22 becomes redundant if the Committee is in favour of thematic reporting;
- k) rule 25 should provide the possibility for the Committee to act upon ad-hoc situations and urgencies/aggressive violations in member states to address a specific issue which is also complementary to the thematic reporting;
- 1) change the wording "conduct an inquiry" in Rule 25.2 which is too strong and goes beyond the mandate of a Committee;
- m) the role of the group of experts could also be, as an added value, to guide and advice the ONE in FIVE campaign which accompanies the Convention;
- 13. Following the first reading of the draft RoP, the Chair concluded that the Committee was not in a position to adopt the text at this first meeting. It was therefore decided to:

- 1. postpone adoption of the draft Rules of Procedure to the Committee's next meeting in 2012, and entrust the secretariat (Children's Rights Division) to prepare a revised version of the draft Rules of Procedure, reflecting the Committee's discussion, by December 2011;
- 2. entrust the secretariat with the task of coordinating the request to the delegations to submit to the secretariat by mid-January 2012 a maximum of four priority themes for the evaluation process;

Item 8: Other business

14. The Committee also decided:

- 1. to invite Ms. Madi Sharma, Member of the European Economic and Social Committee (EESC), to share with the Committee her experience on the collection of good practices in the fight against sexual abuse of children; and
- 2. to include on the agenda of the next meeting a "tour de table" which will allow the participants to inform the Committee about developments at national level as regard the signature, ratification and implementation of the Convention.

15. The Committee was informed by the Croatian representative, Mr. Ivan Crnčec, Ministry of Justice, that his country's instrument of ratification of the Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse had been deposited to the Treaty Office of the Council of Europe that same day, on 21 September 2011. The Chair congratulated Croatia in the name of the Committee for this achievement, which raises the total number of ratifications to 15.

Item 9: Possible dates of the next meeting

16. The next meeting of the Committee of the Parties to the Council of Europe Convention on the protection of children against sexual exploitation and sexual abuse (T-ES) will be held on 22-23 February 2012 in Strasbourg, France.
