ABOUT THE CONTEXT

■ According to estimates, one child in five would be a victim of sexual violence. Many cases could be averted if adequate prevention policies and measures were established. The Council of Europe ONE in FIVE Campaign to stop sexual violence against children has two main goals:

- ▶ to achieve further signature, ratification and implementation of the Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse (the Lanzarote Convention);
- ▶ to equip children, their families, carers and societies at large with the knowledge and tools to prevent and report sexual violence against children, thereby raising awareness of its extent.

■ The Lanzarote Convention was conceived to end the impunity of sexual offenders, protect child victims and prevent sexual violence. This Convention is the international community's most consummate response to the phenomenon of sexual violence against children. The Convention has been signed by 46 States out of which 29 have ratified it and are therefore legally bound by its provisions.

■ In order to ensure monitoring of its implementation, the Convention set up a body called the Lanzarote Committee. As well as assessing the situation in each State Party to the Convention, the Lanzarote Committee acts as a forum for examining problems common to several countries and for pooling solutions which have yielded positive results (good practices).

AIM OF THE CONFERENCE

■ The aim of this Conference is to enable the 47 Council of Europe member states to address the issue of preventing sexual exploitation and sexual abuse of children by taking the provisions of the Convention as a starting point.

■ Built upon the principal challenges of prevention, the Conference will serve to present an overview of the various problems and discuss the solutions applied in Europe. It will also permit recognition and promotion of the role of the various policies (on education, social services, communication, justice and health), the national, regional and local authorities, civil society, the private sector, families and children in developing and implementing actions and policies of prevention.

■ Organised by the Council of Europe in co-operation with the Spanish Government (in particular with the Ministry of Justice and the Ministry of Health, Social Services and Equality), and with the support of Fundación “La Caixa”, the Conference will give pride of place to a selection of good practices identified in Spain.

PARTICIPANTS

■ The Conference will bring together some 180 participants from about fifty countries. Besides the members of the Lanzarote Committee (representing their respective governments), we await numerous experts in the fields of justice, education, child welfare, social and family policies, health, research and communication. These experts represent governments, international organisations, independent institutions, the private sector and civil society.

WORKING METHODS

■ To derive maximum benefit from the potential of the Conference as a forum for pooling good practices, the working methods envisage:

- ▶ Informal presentation of good practices during the coffee and lunch breaks, in a specially arranged area ("Good practice circuit")
- ▶ Formal presentation of good practices at each of the round tables on the Conference programme.

■ In order to garner a maximum amount of experience, the Lanzarote Committee has issued an open call for good practices which should enable us to build up a worthwhile database and to illustrate the wealth of measures to prevent sexual violence taken at the international, national, regional and local level.

■ The Programme is built on five plenary working sessions, each introduced and moderated by an expert who will invite the public to put questions and make remarks and suggestions.

■ The presentations and conclusions will subsequently be made public and posted on the Council of Europe website, and will serve as a guide to its future work.

■ The working languages of the Conference will be English, French and Spanish; simultaneous interpretation between these languages will be provided.
