Dear Madam,

On 26 May 2015, the applicant wrote a letter to the Prosecutor General. By that letter and in line with Article 204 of the Code of Criminal Proceedings (written notification about a crime), the applicant formally notified the Prosecutor General about the alleged crime committed by the judges against him. The applicant points to the 12 rulings of the Azerbaijani's courts which, according to the ECHR judgment, violated Articles 5 and 18 of the Convention.

Based on the specific paragraphs of the ECHR judgment, such as §§118,143, and etc., he informed that the responsible judges committed crimes against him punishable under Article 295 of the Criminal code ("knowingly delivery an unjust judgment, ruling...").

According to Article 10 of the Law "On prosecution" and Article 101 of the Law "On Courts and judges", the applicant asked the Prosecutor General to request from the Judicial – Legal-Council a consent on institution of criminal proceedings against the judges.

He included the list of the judges to the formal notification.
