**MEETING REPORT**

---

### **Item 1: Opening of the meeting, adoption of the agenda and order of business**

1. Drafting Group D on the reform of the Court (GT-GDR-D) held its 2<sup>nd</sup> meeting in Strasbourg from 15-17 May 2013 with Ms Inga REINE (Latvia) in the chair. The list of participants appears at Appendix I. The agenda, as adopted, appears at Appendix II. The Group then heard a welcoming address from Mr Jörg POLACKIEWICZ, Head of the Human Rights Inter-governmental Co-operation Division.

### **Item 2: Toolkit to inform public officials under the Convention**

2. Mr Martin EATON, expert-consultant, presented his revised draft toolkit to inform public officials about the State's obligations. The Group welcomed and examined the draft. Concerning the second part, namely the Checklist for public officials, the Group considered that it would be very difficult to establish an exhaustive list of situations with which public officials may be confronted and points that they should verify. It should not, therefore, refer to too precise situations. It also considered that the questions should aim at recalling Convention obligations and not the requirements of each national legal system. Each member State could complete the checklist so as to adapt it to its own system. Concerning in particular treatment of prisoners, the Group agreed to establish a list of questions common to treatment of any person deprived of their liberty, followed by lists of questions specifically relevant to the treatment of criminal detainees, migrants and psychiatric patients.

3. The Group asked Mr Eaton to prepare a revised version of the Toolkit including the further changes proposed by the Group, with a view to its presentation to the DH-GDR at its next meeting (5-7 June 2013). The Group thanked Mr Eaton warmly for his contribution to its work.

### **Item 3: Guide to good practice in respect of domestic remedies**

4. The Group examined and adopted the draft Guide to good practice in respect of domestic remedies as it appears at Addendum II, with a view to its transmission to the DH-GDR for examination at its next meeting (5-7 June 2013). The Group agreed that only examples of good practice that had been validated as such by the Court should appear in the guide. It recalled that at its 3<sup>rd</sup> meeting, the DH-GDR had decided that the Guide would not address in any detail the issue of effective remedies for excessive length of proceedings, noting that Committee of Ministers' Recommendation accompanying Guide to good practice could be updated in future: the examples of good practice concerning this issue submitted by experts as part of the present exercise could form a useful basis for any future such work.

5. The Group recalled that its terms of reference also covered paragraph 9.c)iv) of the Brighton Declaration, concerning the taking into account by national courts and tribunals of relevant principles of the Convention, having regard to a preliminary exchange of views on the proposal presented by the United Kingdom expert for a section of the Guide dealing with this issue. Experts' views were divided on this aspect of the terms of reference required separate action to be taken, i.e. whether the proposal should be included in the text of the Guide or whether it should become a separate document. The Group regretted that, for lack of time, it was unable to give full consideration to the

proposal and therefore asked the United Kingdom expert to prepare a revised version on the basis of comments received from members of the Group. The Group further decided to propose to the DH-GDR that the latter invite its members to send, in good time before its next meeting, any written comments on the revised proposal. On the basis of these elements, it would fall thereafter to the DH-GDR to decide how to proceed.

**Item 4: Ways to resolve the large numbers of applications arising from systemic issues identified by the Court**

6. Ms Geanina MUNTEANU (Romania), rapporteur, presented the draft report on ways to resolve the large numbers of applications arising from systemic issues identified by the Court. The Group examined and adopted the CDDH draft report as it appears at Addendum I, with a view to its transmission to the DH-GDR for examination at its next meeting (5-7 June 2013). The Group thanked Ms Munteanu for her contribution to its work.

7. The Group wished to record that the suggestion that the Court suspend its treatment of new applications for a certain period following the adoption of a judgment containing general measures for addressing a systemic issue, made during the first meeting, was not retained in the draft report as it considered that this was in effect a suggestion that the deadline for submission to the Committee of Ministers of action plans for the execution of judgments relating to systemic issues might be reduced: such action plans were precisely those that needed the most time for preparation, as they required important policy decisions; and in any case, the period was already short and any reduction could make little difference.

8. The Group regretted that it had not had the benefit of information from those States directly concerned on their experiences and appreciation of the procedural approaches mentioned in Section V of the report, concerning the Court's envisaged procedure'. It encourage such information, preferably in written form, to the next DH-GDR meeting, when the report would be further examined. In particular, the Group considered that paragraph 27 of the draft report, which encapsulates its initial responses to these practices, would require further attention, especially in the light of any information received from the States directly concerned.

9. The Group also saw interest in the DH-GDR hearing more from other States confronted by systemic issues, including in relation to their dealings with the Court and their experience of targeted technical assistance programmes. It encouraged such States to provide information, preferably in written form, to the next DH-GDR meeting, when the report would be further examined.

10. Finally, the Group considered that there would be a need for the DH-GDR to consider taking position on the proposal for a 'special secondment procedure report), if possible.

**Item 5: Adoption of the conclusions and meeting report**

11. The Group considered that, subject to the concerns mentioned above, it had fulfilled its terms of reference in the light of the guidance given by the DH-GDR. It expressed its appreciation for the constructive approach shown by members throughout its work and its thanks to the Chairperson for the way in which she had conducted its meetings.
