ACTION PLAN

On the execution of the judgments of the European Court of Human Rights in cases No. 16967/10 Kalinkin and Others v. Russia (judgment of 17 April 2012, final on 24 September 2012) and No. 5734/08 Ilyushkin and Others v. Russia (judgment of 17 April 2012, final on 17 July 2012)

Violation

In cases no. 16967/10 «Kalinkin and Others v. Russia» and no. 5734/08 «Ilyushkin and Others v. Russia» the European Court of Human Rights found violations by authorities of the Russian Federation of Article 6 §1 of the Convention and Protocol no.1 to the Convention in relation to 50 applicants, in view of the failure to execute decisions issued by garrison military courts on granting of servicemen of the Ministry of Defence, officers of the Ministry of the Interior and the Federal Security Service with housing, as well as of Article 13 of the Convention - in view of the fact, that the applicants have no effective remedies in relation to the above mentioned violations.

I. Individual Measures:

1. Just satisfaction

Due to the found violations the European Court awarded the applicants the satisfaction amounts which have been paid to the applicants in full.

2. Measures for enforcement of domestic courts decisions on granting with housing.

2.1. Judgment on application «Kalinkin and Others v. Russia»

At present the court decisions in relation to the applicants A.I. Golubeva, M.M. Lukyanchuk, A.V. Varchenko, S.Yu. Bessonova, V.P. Starodubtseva, O.A. Timofeyeva, F.G. Kobeleva and V.V. Parshina are executed in full. The above mentioned applicants were provided with housing, and contracts of social rent were concluded with them.

In relation to the applicants A.V. Kalinkin, V.A. Neshumov, N.I. Murzin, V.G. Martynenko, V.A. Shuvayev, A.Yu. Semenov, A.Yu. Kovalkov, O.N. Shmotkin, A.A. Gukasyan, I.I. Dubovitsky, E.A. Grinko and A.V. Platonov the decisions on allotment of housing, and the work on conclusion of contracts of social rent was organised.

The applicant A.S. Bespalov was allotted the housing, and he was informed that the contract of social rent will be concluded with him after he vacates the service housing premise occupied at present.

The court decision in relation to R.G. Sharafutdinov has not been executed so far in view of the lack of vacant housing for allotment, but at present the decision on granting the applicant housing allowances was adopted.

2.2. Judgment on application «Ilyushkin and Others v. Russia»

At present the court decisions in relation to the applicants P.N. Ilyushkin, Yu.A. Shurevich, V.D. Sedinkin, S.A. Zykov, A.A. Potapov, V.G. Udovichenko, Yu.G. Kovryzhenko, N.V. Kuzmin, S.V. Vorobyev, S.V. Zyuzin, V.V. Oshchepkov, R.V. Alekseyev, A.N. Dutskov, V.A. Chesnokov, A.M. Tokhtayev, I.Yu. Lukin, A.V. Novikov, B.P. Nadezhkin and A.G. Pasko are fully executed. The above mentioned applicants were provided with housing, and contracts of social rent were concluded with them.

The decisions on allotment of housing were adopted in relation to the applicants U.S. Adilov, V.Ya. Repp, I.I. Dubovitsky A.G. Roshchin, V.I. Misnikov, I.I. Denisov, N.A. Mikhalev and R.G. Bariyev, and the work on conclusion of contracts of social rent with them was organised.

The court decision in relation to V.Yu. Kozlov has not been executed so far, in view of the lack of vacant housing for allotment, but at present the decision on granting the applicant housing allowances was adopted.

II. General Measures:

- 1. The Federal purpose-oriented program "Housing" for years 2011-2015 was approved by the Resolution of the Russian Federation Government of 17 December 2010. The purpose and tasks of the above mentioned program is the financial support to the Russian Federation citizens, whom the state is obliged to provide with housing in compliance with national legislation, by means of:
- granting the social benefit for purchase of housing, which allows the individuals the participants of the program to purchase housing in the market, with the use of the social benefit, as well as by additional mobilization of own or credit funds (if an individual, for some reason, has not used the right for obtaining the social benefit, allotted to him, he shall be left in the lists of those who are in need of housing);
 - provision with housing.

The total volume of the program financing makes RUB 162,8 bln.

The program implementation shall allow to provide 82 thous. of families with housing before 2015 inclusive.

- 2. The President of the Russian Federation issued the Decree of 7 May 2012 No.604 «On further improvement of military service in the Russian Federation», which stipulates the complex of measures for improvement of the social status servicemen's social status it is stipulated, inter alia:
- provision of servicemen of the Armed Forces of the Russian Federation, other forces, military units and bodies with housing in full in compliance with the legislation of the Russian Federation;
 - formation of service housing by 2014.
- 3. The competent public authorities took a number of measures, directed at ensuring of execution of the court decisions on provision of servicemen and persons equivalent to them with housing upon the court decisions, issued earlier.
- 3.1. The Main Military Prosecutor's Office held examinations of legislative execution in the area of relations concerned. Upon their results, the documents of the prosecutor's response were introduced to the Heads of the Ministry of Defence of the Russian Federation, Ministry of Internal Affairs of the Russian Federation, Federal Security Service of Russian Federation.

Upon the results of the prosecutor's examinations, the housing rights of more than 17 thous. of servicemen and members of their families were restored, more than

120 guilty officials were brought to disciplinary responsibility, 14 criminal cases were initiated.

According to the information from the Main Military Prosecutor's Office, the supervision over the execution of the housing legislation by the bodies of military administration, inter alia, at provision of servicemen and other individuals with housing on the basis of the court decisions, was organized on an ongoing basis and referred to the priority directions of the bodies of military administration activity.

- 3.2. The court bailiffs and prosecutors held the joint examinations of the draft budgets of municipal entities. Upon the results of examination of proposals, made after such examinations, the relevant budgets were adjusted in time, and the presence of expenditure activities, connected with provision of individuals with housing, was ensured in them.
- 3.3. The Federal Bailiff Service and the Ministry of Defence of the Russian Federation held the joint meeting on the settlement of topic issues of execution of court decisions on provision of servicemen with housing, with adoption of certain decisions.
- **3.4.** Under the procedure of implementation of measures upon the suggestions of the Main Military Prosecutor's Office and the Federal Penal Service, within the allocated budgetary appropriations, the Ministry of Defence of the Russian Federation concluded additional state contracts for construction of houses to be allotted to servicemen, subject to discharge from service, inter alia, in the most problematic zones:

Moscow (approximate completion date of a project – 2013-2014);

Belgorod (approximate completion date of a project – 2014);

Rostov-on-Don (approximate completion date of a project – 2014):

Zelenograd (approximate completion date of a project – 2014);

4. The European Court judgments in the cases «Kalinkin and Others v. Russia» and «Ilyushkin and Others v. Russia» were forwarded to the Constitutional Court of the Russian Federation and to the competent public authorities (the Supreme Court of the Russian Federation, the General Prosecutor's Office of the Russian Federation, the Main Military Prosecutor's Office, the Federal Bailiff Service of Russian Federation, the Ministry of Defence of the Russian Federation, the Ministry of Internal Affairs of the Russian Federation, the Federal Security Service of Russian Federation, the Moscow City Court, the Far Eastern District Military Court, the North-Caucasian District Military Court, the Moscow District Military Court, the Leningradsky District Military Court) for taking into account in their practice and taking of measures for prevention of similar violations in future, within their jurisdiction.

The competent public authorities forwarded the copies of the European Court's judgments to their structural subdivisions and territorial authorities with necessary instructions to take into account the European Court's legal positions in their practice.

5. The European Court judgment on applications «Kalinkin and Others v. Russia» and «Ilyushkin and Others v. Russia» was posted in the Russian language in legal reference systems "KonsultantPlus" and "Garant".

6. The work on adoption of other general measures, directed at solution of the issue of lengthy failure to execute the decisions of national courts, is performed by the authorities of the Russian Federation under the group of cases "Timofeyev".
