Orchowski v. Poland

Dear Madam,

In accordance with Rule 77 §§ 2 and 3 of the Rules of Court, I enclose a copy of the Chamber's judgment in the above case. This notification constitutes delivery of the judgment.

The judgment is now available on the Court's Internet site (<http://www.echr.coe.int>).

With reference to the Committee of Ministers' Resolution of 12 May 2004 on judgments revealing an underlying systemic problem (DH Res. (2004)3), the President of the Fourth Section has asked me to notify your Government and the Council of Europe's authorities referred to in this resolution that in this judgment the Court identified such a problem. In particular, the Court held that the overcrowding and, resulting from it, inadequate conditions of the applicant's detention, found to have been in breach of Article 3 of the Convention, revealed a structural problem arising out of the malfunctioning of the administration of the prison system insufficiently controlled by Polish legislation (see paragraph 147 of the judgment).

Your attention is drawn, in particular, to paragraphs 147 and 151 of the judgment, which read, in so far as relevant, as follows:

"147. ...[T]he Court observes that approximately 160 applications raising an issue under Article 3 of the Convention with respect to overcrowding and consequential inadequate living and sanitary conditions are currently pending before the Court. Ninety-five of these applications have already been communicated to the Polish Government.

Moreover, the seriousness and the structural nature of the overcrowding in Polish detention facilities have been acknowledged by the Constitutional Court in its judgment of 28 May 2008 and by all the State authorities involved in the proceedings before the Constitutional Court, namely the Prosecutor General, the Ombudsman and the Speaker of the *Sejm* ... and by the Government

The statistical data referred to above taken together with the acknowledgements made by the Constitutional Court and the State authorities demonstrate that the violation of the applicant's right under Article 3 of the Convention originated in a widespread problem arising out of the malfunctioning of the administration of the prison system insufficiently controlled by Polish legislation, which has affected, and may still affect in the



future, an as yet unidentified, but potentially considerable number of persons on remand awaiting criminal proceedings or serving their prison sentences

The Court concludes that for many years, namely from 2000 until at least mid-2008, the overcrowding in Polish prisons and remand centres revealed a structural problem consisting of "a practice that is incompatible with the Convention"


151. The Court also notes that for many years the authorities appeared to ignore the existence of overcrowding and inadequate conditions of detention and, instead, chose to legitimise the problem on the basis of a domestic law which was ultimately declared unconstitutional As was observed by the Polish Constitutional Court in its judgment of 26 May 2008, the flawed interpretation of the relevant provision, which through its imprecision allowed for an indefinite and arbitrary placement of detainees in cells below the statutory size of 3 m² per person, sanctioned the permanent state of overcrowding in Polish detention facilities.

In the Court's opinion, such practice undermined the rule of law and was contrary to the requirements of special diligence owed by the authorities to persons in a vulnerable position such as those deprived of liberty."

You will find enclosed with this letter a list of applications deriving from the same structural problem, comprising cases which have recently been communicated to the Polish Government and new cases which are currently pending before the Court. The Committee of Ministers will subsequently be informed of further similar applications and of any future procedural decision taken by the Court in connection with its finding of the above systemic violation of the Convention.

I would draw your attention to the circumstances in which the judgment will become final (Articles 42 and 44 § 2 of the Convention).
