European Centre for Global Interdependence and Solidary (North-South Centre) –

Request by Tunisia to accede to the North-South Centre

By letter of 8 August 2014, the Minister for Foreign Affairs of the Republic of Tunisia, Mr Mongi Hamdi, sent an official request to the Secretary General to join the North-South Centre of the Council of Europe. The Secretary General acknowledged receipt of the request by letter of 2 September 2014 (see Appendices 1 and 2 hereafter).

According to the terms of Article 3.2 of the revised Statute of the North-South Centre (see Appendix to Resolution CM/Res(2011)6):

"Other States may be invited to accede to the Centre by a decision of the Committee of Ministers taken by the majority provided for in Article 20.*d* of the Statute of the Council of Europe and by the unanimous vote of the representatives of the member States of the Centre entitled to sit on the Committee after consulting the other members of the Centre."

In accordance with these provisions, Tunisia may be invited to join the North-South Centre, on the basis of a decision of the Committee of Ministers as follows: (1) a decision by the Committee of Ministers taken by the majority foreseen in article 20.*d* of the Statute, which foresees a majority of two-thirds of the votes cast and the majority of representatives with the right to a seat; (2) a unanimous decision of the member States of the Centre which have the right to sit in the Committee of Ministers; (3) a consultation of the other members of the Centre (namely the Holy See, Morocco and Cape Verde).
