Co-ordination of anti-trafficking policies and actions at national and local level

Article 29(2) of the Council of Europe Convention on Action against Trafficking in Human Beings requires States Parties to ensure co-ordination of the policies and actions of government departments and other public agencies against trafficking in human beings, where appropriate, through the setting up of co-ordinating bodies. Under other paragraphs of Article 29, Parties have to adopt measures to promote the specialisation of persons or entities in anti-trafficking action and victim protection, and to provide appropriate training to relevant officials.

Further, Article 5(1) of the Convention requires States Parties to take measures to establish or strengthen national co-ordination between the various bodies responsible for preventing and combating trafficking in human beings.

Pursuant to Article 35 of the Convention, Parties "shall encourage state authorities and public officials to co-operate with non-governmental organisations, other relevant organisations and members of civil society, in establishing strategic partnerships with the aim of achieving the purpose of the Convention". According to the Explanatory Report on the Convention, "strategic partnership" means the setting up of co-operation frameworks through which state actors fulfil their obligations under the Convention, by co-ordinating their efforts with civil society.

Co-ordination and co-operation are of particular relevance when it comes to the identification of victims of trafficking, their referral to assistance and the implementation of other measures to protect and promote victims' rights. According to Article 10 of the Convention, victim identification is a collaborative process between the authorities and relevant victim support organisations. In a number of countries the setting up of a National Referral Mechanism provides a co-operative framework through which state actors fulfill their obligations to protect and promote the human rights of trafficked persons, in partnership with civil society. Further, Article 12 of the Convention specifies that Parties are to co-operate with non-governmental organisations and other civil society actors in the provision of assistance.

Specific objectives:

- Discuss ways in which States Parties meet their obligations under Articles 5(1), 29 and 35 of the Convention, identify different approaches and good practices in the co-ordination at national and local level, and analyse their implications for policy development and implementation.
- Discuss different approaches to National Referral Mechanisms and their impact on the identification of victims of trafficking.
- Identify ways to strengthen co-ordination at national/local level and multi-agency collaboration aimed at the protection and promotion of the rights of victims of human trafficking and improved prosecution of human trafficking offences.

Day 2 - Wednesday, 22 June 2016 (9:00 - 16:00)

Transnational co-operation in the identification and referral to assistance of victims of trafficking in human beings

This meeting will provide the National Anti-Trafficking Co-ordinators and the Permanent Representations of Council of Europe Member States with information on the proposed project on transnational co-operation in the identification and referral to assistance of victims of trafficking in human beings, included in the Council of Europe Programme and Budget 2016-2017.

The idea to launch this project has been developed jointly by the Council of Europe and the International Centre for Migration Policy Development (ICMPD). The objectives are to facilitate the identification, referral, safe return, re-integration and long-term support of trafficked persons, in particular among vulnerable groups, by: i) implementing and further developing transnational referral mechanisms (TRM), and ii) strengthening the capacity of participating countries for efficient transnational co-operation and exchange of information between responsible authorities, including civil society organisations and private sector stakeholders. The meeting will be an occasion to present the proposal and get feedback from interested countries on shared priority areas, discuss current challenges and new priorities, and identify ways to increase co-operation and possible financial contributions.

Specific objectives:

- Present the initiative and get feedback from the interested countries on shared priority areas and possible financial contributions;
- Discuss current challenges in the identification and protection of trafficked persons, in particular among vulnerable groups considering the current migration crisis;
- Identify ways to increase co-operation between countries of origin, transit and destination in the referral of trafficked persons and implementation of harmonised transnational procedures according to the GRETA reports' recommendations.
