

Appendix 1 – Meetings' focus by policy sectors or areas of interest



Based on the titles of the various meetings organised in the framework of the Disability Action Plan, with financial participation or only expertise of the Council of Europe (its Secretariat or its experts), the graph shows main themes considered between 2006 and 2015. 16 meetings were about deinstitutionalisation and independent living. Children's rights and social services issues have been subjects of 13 meetings for each area separately.

Appendix 3 - Texts adopted by the Council of Europe bodies since 2006

The Disability Action Plan has been constantly complemented by the legal instruments adopted by different bodies of the Council of Europe. Apart from the Plan, the Committee of Ministers adopted 8 detailed texts elaborating further on its provisions. 

Appendix 4 - European Court of Human Rights disability case-law



In accordance with the European Convention on Human Rights, individuals can lodge complaints to the European Court of Human Rights (ECtHR) about violations of their rights and a number of cases considered by the Court concern persons with disabilities. Based on the <u>Factsheet of the ECtHR</u> (March 2015), the related complaints, whether admissible or not, were referred to a variety of Articles and rights.

Appendix 6 - European Social Charter


Since the adoption of the revised European Social Charter in 1996, 33 member States out of 47 have ratified the treaty. The Charter provides for selective acceptance of its provisions and it is not obligatory for Article 15 to be accepted. However, most of the States parties to the Charter accepted all paragraphs of Article 15, some ratified one or two paragraphs and only a few have not accepted the Article at all.

Article 15 – The right of persons with disabilities to independence, social integration and participation in the life of the community

"With a view to ensuring to persons with disabilities, irrespective of age and the nature and origin of their disabilities, the effective exercise of the right to independence, social integration and participation in the life of the community, the Parties undertake, in particular:

- 1. to take the necessary measures to provide persons with disabilities with guidance, education and vocational training in the framework of general schemes wherever possible or, where this is not possible, through specialised bodies, public or private;
- 2. to promote their access to employment through all measures tending to encourage employers to hire and keep in employment persons with disabilities in the ordinary working environment and to adjust the working conditions to the needs of the disabled or, where this is not possible by reason of the disability, by arranging for or creating sheltered employment according to the level of disability. In certain cases, such measures may require recourse to specialised placement and support services;
- 3. to promote their full social integration and participation in the life of the community in particular through measures, including technical aids, aiming to overcome barriers to communication and mobility and enabling access to transport, housing, cultural activities and leisure."
