## MEETING OF PARTICIPANTS OF THE PROJECT "SUPPORT PRISON REFORM IN UKRAINE"

Two-day working meeting of the participants of the Project took place in **Kiev** on March 5, 2012.

Welcoming and opening remarks were addressed to the audience by the Project coordinator **Volodymyr Holovatenko**.



Head of the Department of the State Penitentiary Service of Ukraine **Volodymyr Trokhymchuk** was the next speaker. In his speech, he drew attention to the main areas of reforming and expected changes in the management of correctional institutions of Ukraine.



Expert of the Council of Europe **Anna-Katrina Gronöholm** focused her attention on issues of general principles of the European Prison Rules.

Her colleague **Jurgen Van Poecke** focused attention on issues of classification of prisoners and argued about the procedures of their admission to the institutions, assessing risks and needs (the methods and practices used in the Belgian prisons).

The role of prison labor and training of prisoners, preparing prisoners for release were presented by **Theo de Groen**. He also raised an issue of prison regime and measures of safety.



## PRESENTATION OF RESEARCH "OFFENDERS' RISK AND NEEDS ASSESSMENT"

A study focused on offenders' risk and needs assessment was presented by the experts of the Council of Europe in **Kozyn (Kyiv region)** on June 11-12, 2012.

## STUDYING THE PRISON SYSTEM OF NETHERLANDS

A study tour of the delegation of the State Penitentiary Service of Ukraine to the **Netherlands** took place in the period from 25 to 30 November 2012.

This event was concerned visits to the Dutch penal institutions, meetings with managers and prison officers of the Prison Service, scientific researches and practical trainings.



The delegation was presented with Ukrainian correctional officials who were involved in the Project of the Council of Europe "Support for Prison Reform in Ukraine" (prison management component):

- **Serhiy Bogunov**, assistant of the Head of the State Penitentiary Service of Ukraine;

- **Alla Grygorenko**, senior inspector on education and vocational training of the Department of Staffing and Health Protection of the State Penitentiary Service of Ukraine;

- **Mykola Ryzvanyuk**, deputy head of the Faculty of the Institute of Penitentiary Service;

- **Constantine Sverdlin**, head of HR management of the Department of the State Penitentiary Service of Ukraine in Kharkiv region;

- **Vyacheslav Dubets** - Head of the Berezan Penitentiary (№ 95) of the Department of the State Penitentiary Service of Ukraine in Kiev and Kiev region;

The purpose of the study tour to the Netherlands was to investigate:

- structure and tasks of the penitentiary system of the Netherlands;
- procedures and conditions of execution of criminal punishments (including imprisonment) in correctional institutions of various types and levels of security;
- specific features placement and detention of persons suspected of committing a crime in pre-trial prisons;
- procedures and conditions of application of TBS measures to prisoners (means compulsory psychiatric treatment in special institutions);
- specific features of managing of women's prisons;
- specific features and conditions of detention of juveniles in prison establishments;
- specific features for professional of officers of the Prison Service of the Netherlands;
- programs of offender rehabilitation, including preparing them for release
- the role of probation officers in the organisation of work with prisoners;
- cooperation of correctional institutions with NGOs in the sphere of social adaptation of released prisoners.

## THE SECOND SEMINAR "EFFECTIVE LEADERSHIP AND MANAGEMENT" (KYIV)

The second seminar "**Effective Leadership and Management**" was conducted in **Kiev** on January 31, 2013.

The seminar was conducted for heads of correctional and pre-trial prisons from Kyiv, Cherkasy, Zhytomyr and Chernihiv regions.
