


Overview of the GLACY logical framework

- A total of 165 activities have been planned and completed in the course of the project, with a large majority (118) being delivered at the premises of the priority countries' criminal justice authorities.






GLACY-Overview of activities by country



Accession to the Budapest Convention Adhésion à la Convention de Budapest

- As a minimum the instrument for accession must include the **competent authorities for extradition** (Article 24), **MLA** (Article 27) and **24/7 POC** (Article 35).
- L'instrument de adhésion doit comprendre, au minimum, **les autorités compétentes d'extradition** (Article 24), Entraide Judiciaire (Article 27) et 24/7 Points de contact (Article 35).
- **Reservations and declarations** can be made according to the domestic legislation.
