Introduction

The European Landscape Convention Information System of the Council of Europe aims to promote the implementation of the European Landscape Convention and help provide mutual technical and scientific assistance through the collection and exchange of landscape experience and research, as provided for in Article 8 of the Convention. The Parties undertake to co-operate in order to enhance the effectiveness of measures taken under other articles of this Convention, and in particular “to exchange information on all matters covered by the provisions of the Convention”. At its 1187th meeting, 11-12 December 2013 (CM/Del/Dec(2013)1187), the Committee of Ministers adopted Recommendation [CM/Rec\(2013\)4](#) on the European Landscape Convention Information System of the Council of Europe and its glossary.

The Secretariat of the Council of Europe has sent by e-mail a password to the national representatives in charge of implementing the European Landscape Convention who are also correspondents of the Information System of the Council of Europe European Landscape Convention (ELC L6) (List in the Appendix).

Several national representatives began to fill in the questionnaire and some have validated it. All national representatives are invited to validate it for the holding of the 9th Conference of the Council of Europe on the European Landscape Convention to be held in Strasbourg on 23-24 March 2017.

Action required

The Bureau is invited to take note of the information provided and strongly urge – through the Secretariat – all national representatives who are also correspondents of the Information System of the Council of Europe European Landscape Convention, to kindly complete and validate the online questionnaire by the end of 2016.
