## Context

Involving mayors, associations of local and regional authorities and members of the Congress, this seminar will build on the previous exchanges held, between October 2015 and June 2016, during "Mayors, leaders for change" workshops and the regional seminar on "Local public ethics: from vision to action". The aim will be to reinforce the accountability of local authorities, and to provide a platform for exchange on the challenges and solutions when engaging citizens in local decision-making.

The seminar is organised by the Congress of Local and Regional Authorities of the Council of Europe (the Congress) within the thematic programme "Strengthening institutional frameworks for local governance", implemented jointly with the Council of Europe Centre of Expertise for Local Government Reform, Directorate General of Democracy. This programme is funded by the European Union and the Council of Europe, and implemented by the Council of Europe, through the Programmatic Co-operation Framework for 2015-2017 for Armenia, Azerbaijan, Georgia, Moldova, Ukraine and Belarus.
