37th GRECO Plenary Meeting
(Strasbourg, 31 March – 4 April 2008)

DECISIONS

At its 37th Plenary Meeting (Strasbourg, 31 March – 4 April 2008), the Group of States against Corruption (GRECO):

1. adopted the agenda as it appears in the Summary Report of the meeting (Greco (2008) 8E);

2. took note of the information provided by the President, the Vice-President, Delegations and the Executive Secretary as detailed in the Summary Report of the meeting (Greco (2008) 8E);

Third Evaluation Round

3. adopted the Third Round Evaluation Reports on:
 - Estonia (Greco Eval III Rep (2007) 5E – Themes I and II)
 - Iceland (Greco Eval III Rep (2007) 7E – Themes I and II);
4. invited the authorities of Estonia and Iceland to authorise, as soon as possible, the publication of the reports mentioned in decision 3 above;

Joint First and Second Evaluation Rounds

5. adopted the Joint First and Second Round Evaluation Report on Switzerland (Greco Eval I-II Rep (2007) 1E);
6. invited the authorities of Switzerland to authorise, as soon as possible, the publication of the report mentioned in decision 5 above;

First Round Compliance Procedure

7. noted with satisfaction the authorisation to publish the Addenda to the First Round Compliance Reports on Bosnia and Herzegovina and on Moldova adopted at GRECO 34 (October 2007) and GRECO 36 (February 2008) respectively;

Second Round Compliance Procedure

8. adopted the Second Round Compliance Reports on:
 - Cyprus (Greco RC-II (2008) 1E) and
 - Hungary (Greco RC-II (2008) 4E);
9. noted with satisfaction that the authorities of Hungary authorise the publication of the report mentioned in decision 8 above;
10. invited the authorities of Cyprus to authorise, as soon as possible, the publication of the compliance report mentioned in decision 8 above

Joint First and Second Round Compliance Procedure

11. adopted the Joint First and Second Round Compliance Report on Turkey (Greco RC-I/II (2008) 2E);
12. invited the authorities of Turkey to authorise, as soon as possible, the publication of the compliance report mentioned in decision 11 above;

13. held an exchange of views with Mr Martin KREUTNER, Chairman of European Partners against Corruption (EPAC);
